

1. SUMMARY DESCRIPTION OF PROPOSED ACTIVITIES FOR 2008

1.1. Research

For 2008 the following research activities were proposed in the two research lines:

Line I)- Democracy, rule of law and human rights

I a - Survey data analysis in 2007- Data collection for the 4th wave of the survey: the fourth survey data to be used to close this period of data collection representing nearly a decade. Joint analyzes of the results of the three previous waves would demand the conclusion of data reduction, writing up the process of defining the Exposure to Violence Scale (ETV); and the statistical analysis of effects of exposure to violence on fear, and on attitudes to punishment and human rights; exposure to violence and the perception of neighborhoods: social disorganization, civility/incivility in interpersonal contact and on social capital; exposure to violence and trust in institutions, delegation of power, and the acceptance or rejection of the use of force for social control, exposure to violence and the use of physical punishment; exposure to violence and shared representations of the causes of violence and acceptance/rejection of the use of violence are some of the analysis that would continue in 2008.

Supplementary analysis was to focus on age group, gender, race, educational level, income and place of residence. These analyses will result in a book, and a number of papers to be written by various members of NEV. Analysis of qualitative data on human rights collected throughout the 1990's will start running simultaneous to the analysis of the surveys.

I b - Analyses of everyday conflicts- This study analyses data available at the NEV on socially shared representations of conflicts. The data were collected through focus groups with different SES and age groups, with civil servants working (teachers, health professionals, police officers, postmen, social workers) in high violence and high poverty areas, civil society leaders in the same areas complemented with data from the surveys. The analyses was to identify whether there are patterns of conflicts between residents and what relations exist (if any) between these patterns and access (or lack of) to human rights as well as attributions made by respondents as to the causes of such conflicts and whether they indicate any awareness of relations between interpersonal conflicts and access to rights.

I c - The criminal justice system, democracy and human rights- 1- Continuation of the project Violence, impunity and trust in democracy during 2008 includes: 1) finishing data collection, 2) Construction of database, 3) cleaning and correction of database, 4) Quantitative data analysis

(descriptive and regression analysis), 5) production and submission of papers for publication (quantitative analysis), 6) begin qualitative data analysis.

- I d The post-doctoral project conducted by Wânia Pasinato with a fellowship of FAPESP had the following activities programmed for 2008:
- a) literature review on: the incorporation of the category of gender in Brazilian studies about violence against women in particular that which analyzes the action of criminal justice in cases of violence against women; theoretical production about gender definition, intersection of gender, patriarchy and violence in Brazil; ii- homicide in Brazil and the new use of the category women homicide (feminicidio) in the national literature; and b) empirical research, data collection estimated to be finished in February 2008. Results from both literature and empirical research will be presented in a final report, as well as in articles and papers to be presented in national and international seminars. Abstracts were to be submitted to the national congress of ABA (Porto Seguro, June, 2008) and ANPOCs (October, 2008).
- I e The research team on the historical research was to carry out an integrated analysis of data on public security policies guidelines during XX century, to analyze the profile of members of the elites that were active in the public security field, and the impact of governmental action in the efficacy of social control institutions. The analysis was to focus in the First Republic (1889-1930), the 1950's and the last decades of the 20th century.
- If The extra-judicial mechanisms of reparations for the victims of violations of human rights: the Latin-American experience. A joint project of research with Unité Mixte de Recherche en Droit Comparé (UMR - Sorbonne/Paris1) proposed to compare Latin-American Truth Commissions and to analyze why Truth Commissions did not progress in Europe. On the European side, the study will be restricted to the Bosnia experience and the role of the Parliamentary Assembly of Council of Europe. concerning the recognition of European States of the present and past crimes as the Parliamentary Assembly adopted, at the beginning of 2006, a new Resolution about the need for an international condemnation of the crimes of the totalitarian communist regimes. Weekly seminars were to be continued, to discuss the contributions of Hannah Arendt, specially related to totalitarian regimes, responsibility and judgments and pardon.
- I g Democracy, Justice and Human Rights: Critical Theory Studies- In 2008 the project goals were: publish papers, organize symposiums, study possibilities of partnerships with foreign Universities and produce theoretical work based on NEV's empirical studies.

I h - Police Ombudsoffices Project - The main objective of the project (part of a partnership between NEV/USP and Secretaria Especial dos Direitos Humanos) is to define a methodology to collect and analyze data on the use of lethal force by the police.

This methodology was to be transferred to state Police Ombudsman across Brazil. It was expected that a uniform methodology to follow cases of the use of lethal force by the police would strengthen the Ombuds offices as an external form of control. It was expected that this project contributes to reduce lethality by the police forces through a clear monitoring process. It was also expected that, to some extent, in-depth knowledge about the use of lethal force by the police would be gained and comparisons within the country made possible once the definition and methods used to measure lethality are standardized.

Line II) Monitoring Human Rights Violations

It was expected that the human rights' indicators, in particular indicators of access to rights, and that the treatment of data on human rights violations would be refined, in particular these on police violence, execution and lynching. Another objective was to promote debate on quality of existing governmental, and non-governmental data on monitor human rights and how this is reported on the media. A third goal was to refine the methodology to measure police violence, explore the causes for this violence focusing on the responses of the criminal justice system. Fourthly it was expected that NEV would produce Human Rights bulletins: monthly, quadric-annual and bi-annual as well as prepare the 4th National Report on Human Rights in Brazil (2006-2008) and the Report on Citizen Security and Human Rights in the Americas.

II a - Analysis of Homicide of children 10-14 years in Brazil 1980-2005.

Homicide was the 12th cause of death in the age group 10-14 years in 1980 (1,5% of all deaths) and in 2005 it was the 4th cause of death, (9,5% of all deaths). This paper analysis mortality data from the health system as well as that from NEV data bases on lynching, execution and police violence in order to identify the profile (gender, age, large cities, regions of the country) as well as by what means these children die and what works in terms of prevention. Causes for the greater risk for children aged 13 to 14 are sought in the child development literature. This analysis is nearly completed.

II b - Violence, Risk and Vulnerability: homicides and human rights violations in São Paulo

In 2008 it was expected that this study would include the following activities: 1) preparation and submission of papers based on multivariate (logistic regression) analysis, 2) Qualitative data collection: through contacts with Victim's Support Group- a group that provides psychological support to families of homicide victims, carry out in-depth interviews (life stories) with surviving relatives, exploring, from their perspective, the course of events that led to the death of youths; analysis of the case studies and 3) Preparation and submission of papers based on life-stories analysis, 4) Weekly seminars with the research team.

Il c - Improving access to rights - a home visitation project - The following activities were to be accomplished in 2008: 1) Review existing home visitation protocols and evaluation instruments, 2) Adapt e develop protocols to be used in Brazil, 3) Conceptual validation of protocols through discussion with experts, 4) Assessment of language used and acceptance of protocols by adolescents and family members through group discussions, 5) Second meeting with international expert advisory group to discuss all the produced protocols, 6) Review the intervention project after discussion with the national and international experts as well as the result from consultations with adolescents and their family members.

1.2. Knowledge transfer

Ist International Seminar on Torture: This Seminar was to take place between the 25th and the 27th of February 2008 (program appended with all participants confirmed). The aim of the Seminar was to promote a broad discussion on torture and its myths. The Seminar was motivated by two concurrent factors: the return of the discussion on the "efficacy" of torture under certain conditions (i.e the "war on terror") and the survival within Brazilian law enforcement agencies of the practice of torture twenty years after the return to democracy. This seminar was to be the first of a series of two seminars with the following objectives: 1- to promote an informed debate on torture and the impact that lowering moral interdictions against torture can have for democracy; 2- to promote exchanges between Brazilian and international scholars and researchers; 3- to encourage networks of national and international scholars in order to more readily inform public debate on these issues.

A book was be edited by NEV based on the contributions made to the seminar. The second seminar will be on "Preventing torture and other forms of violence by acting on their economic, social and cultural root causes", jointly with the World Organization Against Torture. The second international seminar on torture was expected to take place in August 2008 and will involve mostly non-governmental organizations in particular human rights activists.

International Seminar "Measuring Progress and Assessing Impact in Human Rights: The Problem of Police Violence" - This seminar was expected to take place in May 8 e 9, 2008. Objectives were: 1) Discuss national and international experience on the construction and use of indicators to monitor human rights; 2) Discuss the use of the indicators of the human rights to survey police violence; 3) Debate the use of indicators of human rights by governmental and non-governmental organizations to confront police violence; 4) Discuss the role indicators play in informing civil society to confront human rights violations.

Seminar on public security and human rights in the Americas. March 2008. Participants: experts, police officers, government officials and human rights/civil society leaders working on the reform and improvement of police services and public security policies in the region. First of a series of five subregional meetings (Andean, Central and North America and the Caribbean) in the context of the project Citizen Security and Human Rights in the Americas, developed by NEV-USP, in collaboration with Centro de Estudios Legales y Sociales (Cels), for the Interamerican Commission on Human Rights. The project has the support of the Open Society Institute.

Book series on Human Rights: Three titles were to be launched in 2008: - DEVINE, Carol. Direitos Humanos: referências essenciais. São Paulo: Edusp, 2008. -JABINE, Thomas P. (org.). Direitos Humanos e estatística. São Paulo: Edusp, 2008.- CLAUDE, Richard P. (org.). Educação em Direitos Humanos para o século XXI. São Paulo: Edusp, 2008.

Others - Community policing handbook- The objective of the project (a partnership between NEV/USP and Secretaria Especial dos Direitos Humanos) is to produce a training handbook to be used as training material for community policing. The audience for this book are: police patrolling officers and sergeants and corporals of the Military Police, Civil Police and civil society leaders. Objective of the handbooks are: to give theoretical and practical elements to support the training for Community Policing activities. The project is in progress and the following stages completed: review of training materials on community policing (national and international), first analysis of all the literature. Next year the first draft of the handbooks will be written, tested and evaluated in focus groups with the different audiences involved. After this evaluation the final versions will be written.

Cross referencing data from the newspaper data bases on lynching, death squads/execution groups and police violence- A pilot project to allow interactive access to cases of lynching, death/squads/execution groups and police violence. It will be possible for users to obtain data on number of cases per state and for Brazil according with crimes involved and causes attributed to the cases. In the case of data about the state of São Paulo users will also be able to obtain total number of cases per city and district, place and time and police precinct where the case was recorded. This is the first step for an interactive database.

NEV-CIDADÃO (guiadosdireitos)- During 2008 the site was to be extended to cover other cities in the Metropolitan Region aside from São Paulo, besides routine information update.

Website Safety and Citizenship: promotion of violence prevention and transparency in public security sector: One of our researcher was to spend a month at the Institut National de Santé Publique du Québec, responsible for the development of the website Centre québécois de ressources en promotion de la sécurité et en prévention de la criminalité. The objective of this mission was to identify features of this site to transfer it to NEV. Resources for this project were to be sought with the Canadian government.

Electronic periodical of NEV-USP, Democracia, Direitos Humanos e Violência- The first issue will be available by late February and the theme is Hannah Arendt. We are expecting to have three issues by the end of 2008.

The full text news clipping database on gross human rights violations. In 2008 the full text clippings that are now available as pictures will be transformed in text format to allow "google" like searches. This is very time consuming as the quality of images from newspapers do not allow for an automatic transcription to text. The first clippings to be format will be the clippings from editorial and analytical comments that reflect how public opinion leaders viewed gross human rights violations throughout time.

NEV-Unesco Chair on Human Rights Education. NEV will continue to work with the Unesco Human Rights Chair at the Institute of Advanced Studies at the University of São Paulo (IEA-USP).

1.3. Education

Course on Organizational Management in Public Security and Criminal Justice- The course was to start in February 2008 for two groups of 48 students each. Each group consists of equal numbers of civil police and military police officers, public prosecutor and judges. At least 30% of the vacancies will be for women in the careers listed. The course consists of 18 lectures to be delivered by lecturers from the University of São Paulo (the School of Philosophy, Languages and Human Sciences, the School of Economics and Business, and the Polytechnic School), the Getulio Vargas Foundation, the São Paulo School of Public Prosecution University Candido Mendes, State University of Rio de Janeiro, Catholic University of Rio Grande do Sul and the World Bank, the Public Security Police of Setubal (Portugal) and the Centre National de la Recherche Scientifique (France).

2. QUALITATIVE ANALYSIS OF THE PROGRAMMED ACTIVITIES IN THE **PERIOD**

During 2008 a number of unscheduled activities intervened in the development of the programmed activities. The main goal of 2008 was to prepare papers and three books (the proceedings from the Seminar on How to Study Organized Crime, The International Seminar on Torture and the book The Police Citizens Want). It was expected that by the end of the year a new report and a project for the next three years were also to be written. But this programming was disrupted early in the year: in February we were informed that a report for the previous 8 years, and a new project for the next three years, were to be written by mid-April and July when we were informed that the CNPq- National Council for Scientific and Technological Development of the Ministry of Science and Technology had opened a competition for funding National Institutes of Science and Technology in different areas of knowledge and a key requisite was that a network of research institutes, organize around a shared research agenda.

The concept of a National Institute was very much similar to that of the CEPID as it combines research, education and knowledge transfer, but now expanded to include partners across states. This led to an intense series of internal workshops and seminars during which the full team had to exchange research results and discuss literature reviews. As result for nearly 5 months in total, senior researchers were committed to reporting and writing up projects, with the support, in various degrees of intensity from the junior staff. In our assessment this led to substantive improvements in the theoretical framework, and the refinement of the questions we have been seeking to answer: what kind of democracy can develop in The research program explores the paradox of the unstable combination of changes and Brazil. authoritarian continuities in the Brazilian democracy through three research lines: a) The implementation (or lack of) of democratic rule of law: public security or insecurity? b) Public security, police performance and democratic political culture – the preconditions for a culture of human rights, and c) Monitoring Humans Rights - the present, past and future. The study of the quality of governance aims to identify in how far basic tenets of democracy are being respected. The focus is on public security and on access to human rights. Governance is to be evaluated both by the actual results it produces in public security and through how this performance is evaluated by the public, and its effects on the development of a human rights culture and in the support for Rule of Law. Specifically we want to answer the following questions:

Why improvements in economic and social rights, in a context of decline of violence, co-exist with the expansion of organized crime, corruption and gross human rights violations?

- Why, despite improvements, territories dominated by organized crime continue to exist (and even grow), and systemic corruption continues to plague the political, administrative, and judicial spheres?
- Can there be public security without universal access to civil rights, in particular to the right to life?
- What role does impunity play for the development of a human rights culture and in the support of democratic Rule of Law (Morlino, 2004)? What are the pre-conditions for a human rights culture?
- To what extent human rights violations continue to occur in Brazil and who are the groups most at risk?
- To what extent the lack of closure promoted by the general amnesty, a pre-condition for the transition to democracy is an obstacle to effective democratic rule of law? In other words can we have democratic rule of law while denying past violations?
- If democracy and a human rights' culture demand the existence of effective democratic Rule of Law, what can be expected for the future of democracy in Brazil?

The questions we seek to answer are set against the hypothesis about the how the civilizing process has taken place within Brazilian society. We will study extreme cases in which the suspension of laws resulted in temporarily "failed states", in non-universal law enforcement, fear, insecurity and low trust in institutions among the population, to explore what happens to the civilizing process in such contexts. Particular emphasis will be given to the performance of the police. The police forces will be analyzed from the perspective of the quality of their working conditions and of the impact of that this work has on police officers' health, changes that have been introduced to their training, as result of the return to democracy and how these relate to those of neighboring countries and those of consolidated democracies, innovations adopted either on policing practice or investigative procedures and in public security policies. We will also explore how the social identity and representations of the police affect their performance as well as analyze their performance in investigating actual homicide cases.

The paradox of homicide drop combined with the growth of the organized crime, against a background of continued human rights violations, will be analyzed from the perspective of its effects on public support for the rule of law, this means that the evaluation of the quality of democracy places emphasis on the role that law enforcement plays, in particular in ensuring the right to life.

It is possible that part of the resistance to reform that police forces present, may be grounded in the past-particularly in the General Amnesty that defined the conditions for the return to democracy. Thus we will also focus on the role that the unsolved past may have on the present- the role of the amnesty and the denial of access to historical archives, may play in the continued presence of torture, disappearances, and extra judicial executions. Lastly we will continue to intervene to promote access to rights: by transferring knowledge accumulated to the public in general and by promoting the development of one of the most at risk groups.

This research program will be developed jointly with the Federal University of Rio de Janeiro, the Fundação Oswaldo Cruz, the Forum Brasileiro de Segurança Pública, the Federal University of Ceará, the University of Brasília, and the Federal University of Rio Grande do Sul.

Unscheduled activities did affect the analyses, and writing of papers for publication to some degree, but did not prevent data collection. These went on despite the usual difficulties. Other programmed activities in the areas of Education and Knowledge Transfer, in general, followed what was programmed for the year. Another aspect worthy of mention is the increased role that younger researchers have been playing in publications, research field coordination and in presentation in international seminars. Their role in the team is gaining importance and their professional maturing, is believe an important achievement.

The International Seminar on Torture was very successful: the papers presented are a key contribution to the debate on torture in Brazil; the discussion between presenters, and between them and the public, were very intense, but always civil, despite the highly charged content. The seminar attracted the attention of a large public and of the media. Six hundred persons enrolled through the internet to attend the Seminar and the attendance rate was very high. The book edition was delayed because not all authors could fulfill our deadline, but at present all chapters are being reviewed and the translation into Portuguese will start soon. It has been agreed with the University of São Paulo Press (EDUSP) that there will be two editions: one in Portuguese and one in English.

The two other books programmed for 2008: the one with the papers presented at the Seminar on Organized Crime and that on The Police that Citizens Want are being edited, after delays due to tardiness on the part of contributing authors. Both books will also be printed by the University of São Paulo Press (EDUSP). The 4th National Report on Human Rights is under final edition as well and will be launched this year.

The book on "Violence in Schools: a guide for teachers and parents" was adopted by the Secretariat of Education of the State of São Paulo, as a text for teachers and headmasters/mistresses and a second printing with 10.000 volumes is in course.

2.1. Qualitative analysis of research activities

There was progress in the research activities in all the projects:

- a) the 4th wave of the survey (*The quasi longitudinal survey study: exposure to violence and socially shared representations and attitudes to justice, punishment and human rights*) went as scheduled;
- b) data collection on the project on impunity was finished (*Violence, impunity and trust in democracy*) and the study on feminicide was concluded;
- c) the interviews with relatives of deceased youth began (*Violence, Risk and Vulnerability: homicides and human rights violations in São Paulo*);
- d) the project on Police Ombudsoffices in Brazil was concluded and a report on how to standardize definitions, measurements and procedures used in the case of police use of lethal force is under way;
- e) data collection for the 4th National Report on human rights was also concluded and the first draft of the report finished:
- f) The project on the role that Amnesty in Brazil has played in democracy (*The extra-judicial mechanisms* of reparations for the victims of violations of human rights: the Latin-American experience) has also progressed, at a time when public debate about the right to memory, begins to grow in the country.

Data analysis has also progressed in all projects: much effort was placed in the statistical analyses of the survey data and on the data from the project on impunity and in keeping update with the literature in the multiple fields covered by the projects, an activity that is consuming more and more time from researchers. In terms of qualitative analysis, the historical project has produced a profile of three business entrepreneurs who were also key figures in the definition of public security policies at different moments of the past century.

Line I) Democracy, rule of law and human rights

I a- The analysis of the survey data- The quasi longitudinal survey study: exposure to violence and socially shared representations and attitudes to justice, punishment and human rights. The 4th wave of data collection took place in August 2008. The four data sets had to be unified in a single data set for comparisons between the different waves. Though the questionnaire remained the same, the introduction (in 2006) of a question about the prevalence of victimization (ever in your life) caused some difficulties. Initial factorial analyses on the variable exposure to violence produced unsatisfactory results. The variable is constructed on the basis of the responses given to three types of exposure: direct victimization in the neighborhood, and indirect victimization (also in the neighborhood) – watching or hearing about violent offenses. The questionnaire also covers direct victimization at the school, when applicable (i.e. when respondents attend schools) but this victimization- which may or may not overlap with that in the

neighborhood was not included in the scale. In each wave of the survey roughly 15% of the sample still attend school and thus answered about victimization in school.

Since there was the risk that respondent in these circumstances could have been erroneously classified, as having had no experience with violent victimization in the previous year, when this would have been valid for their experience in their neighborhood, but not in school, we reviewed the pattern of response of each individual in all the relevant questions to re-design this variable. This process has been finalized and now new tests are being carried out. Also during this year updating the literature review was a continued activity, for all key research themes: attitudes, beliefs and values to human rights, justice, punishment, law enforcement agencies, trust in institutions, to the use of violence to solve conflicts, the role that social capital plays in the perception of violence.

I b- Analyses of everyday conflicts- A literature review on social justice, access to rights and social conflicts was carried out and training on the use of NVIVO software for the analysis of the transcripts of focus groups discussions started.

I c- The criminal justice system, democracy and human rights-

The project *Violence, impunity and trust in democracy* in 2008 concluded data collection the archives of the judiciary. Also the software to process the data and to adapt the data to be exported from SQL to SPSS was developed, tested and the data inserted in this format. All data entry was reviewed and corrected. Tables for descriptive analyses were extracted and a full preliminary report written with a final version scheduled for March 2009.

The main obstacles faced were, yet again, to fulfill scheduled deadlines. This was due to problems in our access to the Archives of the Judiciary and due to problems in the development of the software. The difficulties in locating and retrieving archival documents, referring to the cases of homicide that comprised the sample, were numerous and in the end it was impossible to locate all the cases selected to compose the sample. This will limit the generalization of research results, as it is impossible to identify, in how far the cases retrieved are representative of homicide cases in general, and if not, what is the bias as we have very scarce information about the profile of cases that could not be retrieved.

The objective of the project to *follow-up* cases of homicide was achieved: 197 cases of homicide were retrieved, and these cases presented the following outcomes: 71 cases were sent to the archives without indictments- either because they had not been cleared or due to insufficient evidence, whereas 126 resulted in indictments. There were 243 persons indicted and 234 victims in the 126 cases processed. Public prosecutors accepted charges against 65,4% of those indicted by the police but dropped the

charges for 30,8%, and the process was archived, while 3,75 were excluded from charges. Of those were accused by the public prosecutors, judges accepted the charges for 72,3% while refusing the charges for 11,9% and acquitting 5%. Of the 65,4% accused, 86,1% faced trial by jurors and 67,7% were found to be guilty and 27,3% were acquitted. In two cases charges of homicide were reduced to a minor charge and for 14,5 of the accused whose charges had been accepted by the courts 14,5% the case was annulled due to death of the accused before trial.

The data collected has allowed us to answer specific goals of this research: 1- to identify the characteristics of homicide cases in terms of the facts, contexts, and means used, actors involved, the intervention of police forces and the judiciary; 2) comparative identification of the profile of accused who are processed, tried and sentenced vis a vis those for whom charges are dropped along the case or who die before trial; 3) identify the flow of justice in each stage of the criminal justice system in terms of legal procedures adopted and the performance of technical and non-technical agents set against the background of the terms of the legal estatutes that regulate trial of crimes (in process); 4) analyses of the distribution of sentences by type of homicide (manslaughter, murder in the first degree, and so on).

I d- Post-doctoral project conducted by Wânia Pasinato with a fellowship of FAPESP resulted in literature review on the use of the category gender in Brazilian studies about violence against women, a report presented to Fapesp in January 2009 and two papers: 1- Violência, Gênero e Direitos Humanos: Uma análise sobre a distribuição da justiça criminal nos casos de homicídios (Violence, Gender and Human Rights: An analysis of the distribution of justice in homicide cases), 50 pgs; 2- "Femicídios" e as mortes de mulheres no Brasil. Reflexões sobre os fundamentos e implicações políticas desta categoria para o caso brasileiro, (Femicide and the death of women in Brazil: Reflexions on the foundations and political consequences of this category for the Brazilian case) 23 pgs.

l e- Historical research – Analyses of the role that the entrepreneurial elite had in the definition of public security policies in the state of São Paulo resulted in the identification of three key actors in the first half of the 1900's: Cândido Motta, Paulo Duarte and Alfredo Issa Ássaly. The history of their interventions was reconstructed in particular their role in designing legislation and their activities in the state Legislature. Having in common a background in Law, besides pressuring for legislation, the three also established close dialogue with a broad spectrum of professionals from the criminal justice system including from areas such as forensic medicine, psychiatry and criminology. Their proposals for reform in public security policies evidenced the conflicts and ambiguities in society to the concept that rights and protections should be universal entitlements of citizens.

I f- Extra-judicial mechanisms of reparations for the victims of violations of human rights: the Latin-American experiences- Lucia Elena Arantes Ferreira Bastos started a post doctoral project in 2008: "Direitos Humanos e Justica Restaurativa na América Latina" (Human rights and Restorative

Justice in Latin America), with a Fellowship from Fapesp. The project encompasses: a) The theory of restorative justice and b) The application of restorative justice by the Interamerican Court, the recommendations of the Interamerican Commission, and of the reports of the different Truth Commissions in terms of reparations for human rights violations, in particular in cases involving Brazil. Comparisons are being traced between legislations, sentencing, recommendations and reports. It is expected that this analyses will reveal the patterns of repair that result from the sentences issued: compensations, restitution, symbolic reparations. This last stage is near finished and now it is possible to quantify and to establish the nexus between types of violations and reparations and what explains differences in outcomes of cases presented before the Interamerican Court, the Interamerican Commission and the Truth Commissions.

I g- Democracy, Justice and Human Rights: Critical Theory Studies- -Coordinated by Prof. Dr. Eduardo Carlos Bianca Bittar, (Professor of the Law School of USP, Faculdade de Direito da USP), this project approaches the study of democracy, social justice and human rights from the perspective of critical theory, in particular that of the three generations of the Frankfurt School. This project aims to provide a complementary contribution to the different research projects in course at the NEV. In 2008 six seminars were organized covering the contributions that disciplines, such as, psychoanalysis and esthetics present to critical theory. A number of papers were published and presentations at national and international seminars and congresses made.

I h- Police Ombudsoffices Project - The main objective of the project (part of a partnership between NEV/USP and Secretaria Especial dos Direitos Humanos) was to define a methodology to collect and analyze data on the use of lethal force by the police. The methodology is to be transferred to Police Ombudsman in different Brazilian States. It will enforce/empower this institution (external form of control) and help these review their relationship with Departments of Internal Affairs in the police forces (internal control). It is hoped that this project will contribute to reduce lethality of police action through the institutionalization of an independent monitoring process. It will produce an in-depth knowledge about the use of lethal force by the police and encourage more comparisons within the country, once the definition and measurements are standardized.

The study covered all existing state police ombudsoffices across Brazil totaling 14: São Paulo, Bahia, Ceará, Espírito Santo, Goiás, Mato Grosso, Minas Gerais, Pará, Paraná, Pernambuco, Rio de Janeiro, Rio Grande do Norte, Rio Grande do Sul and Santa Catarina. Data was collected, in each of the locations, by pairs of researchers from NEV. In each location data collection included: definition of police lethality used, procedures adopted in cases of use of lethal force, as well as data on the history of the Office, outcomes (reports), work flow, degree of autonomy, independence of the Office from external

pressures. Data collection also included following three Meetings of the National Forum of Police Ombudpersons: two in São Paulo and one in Recife.

Analysis of the data collected in the 14 states, and a review of procedures adopted in developed economies, allowed for a preliminary definition of standards to follow up cases of police use of lethal force based. This preliminary document was then presented to the 14 police ombudspersons in December 2008. Their contributions were incorporated and a final version of the definitions and methodology to measure, and follow up, the use of lethal force is underway. A users' guide is also being written to help police ombudspersons and their teams to implement the methodology.

Line II) Monitoring Human Rights Violations

II.a- The 4th National Report on Human Rights in Brazil (2006-2008)- The 4th National Report on Human Rights in Brazil is in the final draft. State governments were again very reticent to provide information and this delayed the process, as we had to rely on numerous sources to provide a more complete picture of each state while ensuring that data from previous years can be compared to the more recent ones.

In the past year we also expected to: 1) Refine the treatment of the data on human rights violations and the analysis of police violence, execution and lynching, improve the methodology to monitor human rights by developing human rights indicators (including indicators to human rights violations and access to human rights); 2) promote debate on quality of existing governmental, non-governmental and press data to monitor human rights; 3) refine the methodology to measure police violence, explore the causes for this violence focusing attention on the responses of the criminal justice system; 4) produce a NEV Human Rights bulletins: monthly, quadric-annual and bi-annual; as well as prepare the 4th National Report on Human Rights in Brazil and 5) to Report on Citizen Security and Human Rights in the Americas. Out of all the objectives listed above we have achieved: a literature review of police use of lethal force and abusive use of such force; refined the methodology to measure police use of force; identified the responses that the criminal justice system provides to this use of force, in the states with police ombudsoffices, and thus explored the connections between this treatment and the causes for continued use of lethal violence by the police; written the 4th National Report and contributed to the Report on Citizen Security in the Americas. We did not progress in debating the quality of official data to monitor human rights and in the development of more refined indicators of violations and of access. To a large degree, this lack of progress in the two areas, are due to the death of Paulo de Mesquita Neto who was the coordinator of this area. His absence affected the Bulletins as well as he was the mentor of this project and the main supported.

II.b- Analysis of Homicide of children 10-14 years in Brazil 1980-2005. Homicide as a cause of death of early adolescents has been growing in Brazil for the last two decades but remains a largely ignored problem. The paper describes the growth of the problem of pre-adolescents homicide nationally, and explores potential causes and sources of risk for violent victimization for this age group using national and international literature from public health, child development and criminology. The paper is being revised and edited for submission to an international journal.

II.c- Violence, Risk and Vulnerability: homicides and human rights violations in São Paulo - The Project submitted to the Ethics Committee of the São Paulo State Institute of Health (attached to the State Secretariat of Health) and received official approval in July 2008). It was also presented to the State Secretariat of Justice and the Defense of Citizenship for their approval, without which there would be no access to the official Victims'Support group: CRAVI (Center for the Referral and Support of Victims). After approval from both sources, contacts with relatives and friends of youth victims' of homicide started. By the end of 2008 three case studies were completed. Extensive literature reviews were carried out during this period on youth risks, violence and victimization.

Delays were due to the bureaucracy of the State Secretariat of Justice and of the Ethics Committee. Also contacts with relatives and friends of deceased youth has been difficult: CRAVI's staff is not always helpful in liasing the research team with relatives and friends of victims who seek their services; selecting families that meet the criteria for interviews is a slow process, and the refusal of families to take part in the project due to the seriousness of the case, fear or yet lack of emotional conditions to talk about the case. A paper based on the analysis of quantitative data and of the data on gross human rights violations from NEV data bases was approved for publication in the Revista de Saúde Pública: "Graves violações de direitos humanos e desigualdade em São Paulo: uma análise exploratória" (Gross human rights violations and inequality in São Paulo: an exploratory analysis". This apper is to be published in Portuguese and in English.

II.d- Improving access to rights – a home visitation project- This project was submitted to the Ethics Committee of the Institute of Psychology of the University of São Paulo and approved in May 2008. *Preliminary* protocols for home visitation were developed, and the process of testing, their adequacy to the actual conditions of life, of pregnant adolescents living in high risk areas of São Paulo started. Contacts were made with the State Secretary of Health to present the project to the state government and thus take the first steps to draw their attention to the need and opportunity to intervene early on to prevent child abuse and maltreatment. At present protocols for training home visitors are being developed.

Literature reviews of home visitation, parenting, early child development, and prevention of child abuse and maltreatment, were carried out. Other activities included identification of: legislation that protect children and adolescents; programs that target adolescents and children to improve their access to rights; and of health services designed for adolescents' needs; field observation were carried out at existing services for adolescents to identify how professionals relate to pregnant adolescents, what type of information is provided, and what language is used. Places that were visited for observation include: Health Services (Visitas a Unidades Básicas de Saúde) in high risk areas were visited, Casas do Adolescent (Adolescent's House), Centros de Defesa da Criança e do Adolescente (CEDECAs) (Center for the Defense of Children and Adolescents) and NGOs (non-governmental organizations).

A one week long workshop with Dr. Jon Korfmacher (Erickson Institute-Chicago) took place on child development and home visitation. The visitation protocols are being pre-tested with a group of pregnant adolescents residents at the Heliopolis' community (preliminary protocols available at:www.nevusp.org/infanciasaudavel). Study visits were made to Rio Grande do Sul to collect more information on their early child development program — PIM (Improved early childhood) as they are partners in the pre-test of the home visitation program.

The evaluation of the pilot program will use qualitative and quantitative data and start as soon as the intervention sample is selected and visitors are trained. During the last year the protocols for evaluation were developed: indicators were selected; tools were selected after consultations with partners (World Studies of Abuse in Family Environments- WHO; Edinburgh, Scale of post partum depression); questionnaires developed to use with mothers/adolescents and their child; workshop with Brazilian experts to define tools to collect data [Dra. Simone Gonçalves Assis (Claves/Fiocruz), Prof. Lilia Blima Schraiber (USP), Profa. Anna Chiesa (USP), Dra. Maria Sallum (SES-SP), Prof. Alexandre Ferrari (USP), Profa. Cristiane Silvestre de Paula (Unifesp/McKenzie)]; qualitative tools were developed; workshop with Dra. Magdalena Cerda (Univ. New York) to refine the design of the evaluation, and the development of tools and indicators.

2.2. Knowledge transfer-Dissemination Activities in 2008

1st. International Seminar on Torture: As described above this seminar took place between the 25th and the 27th of February (program appended). The proceedings are being published in two languages, also as described above. The seminar had three objectives: 1- to promote an informed debate on torture and the impact that lowering moral interdictions against torture can have for democracy- in this respect the seminar received much attention from the public and the media..... and hopefully the books will provide material for more extensive debate; 2- to promote exchanges between Brazilian and international scholars and researchers- the contacts were quite fruitful but did not last long enough for joint projects to evolve, perhaps in the future these will take place; 3- to encourage networks of national and international

scholars in order to more readily inform public debate on these issues- there is no doubt that we have identified a number of very important sources both for our work, for the public sector (those involved in designing programs to prevent torture) and for the media.

The International Seminar on "Measuring Progress and Assessing Impact in Human Rights: The Problem of Police Violence: Was postponed to 2010 due to Paulo de Mesquita's death.

2nd International Seminar on Torture: scheduled to take place in the second semester of 2008 and to focus on NGOs' strategies to prevent torture this seminar was cancelled because the World Organization Against Torture a partner in the organization changed the nature of the meeting having opted to carry out a number of consultations in different regions: Africa, Asia and Latin America instead of a holding a single large meeting.

Seminar on public security and human rights in the Americas: The project Citizen Security and Human Rights in the Americas, developed by NEV-USP, in collaboration with Centro de Estudios Legales y Sociales (Cels), for the Interamerican Commission on Human Rights and the Open Society Institute. The aim is to publish two reports: one to review the nature of the citizen security crisis in the Americas and the other on juvenile justice in the region. The report will propose clear recommendations for the improvement of the institutions, laws, policies, programs and specially the practices related to public security, the prevention and answers to delinquency, violence and insecurity in the Americas, with due respect to human rights and on juvenile justice. Two questionnaires were sent out, on December 2007, to all 35 states in the region, one for each report. The responses provided by governments can be consulted at the site www.oas.org and soon at the NEV site as well.

Besides official information from governments data is also being colleted from organized civil society (NGOs) and from academia. To this effect eight regional consultations are scheduled, three of which took place last year: in Santa Fé (Argentina), in Assunción (Paraguay), and in Quito (Ecuador). In Santa Fé representatives from Chile, Argentina, Brazil, and Ecuador, after deliberating on shared concerns on public security, formed the Iberoamerican Forum for Citizen Security. A month later this Forum was formally established with the participation of representatives Bolívia, México, Nicarágua, Brasil, Argentina, Chile, Honduras, Colômbia, and Spain who gathered to discuss "Local Governments and Citizen Security". In Assunción a consultation took place on juvenile justice in the South Cone Region: Sub regional Consultation for countries in the South Cone on Citizen Security and Human Rights. This consultation was sponsored by the Interamerican Commission on Human Rights, UNICEF and the United Nations High Commissariat for Human Rights. Participants were: experts, juvenile justice experts, members of the judiciary, police officers, government officials and human rights/civil society leaders.

Five consultations are scheduled for 2009 involving government representatives, NGOs and academics and experts:

in March consultations for Central America and for the Andean Region and in the near future, at dates not yet defined consultations for the Caribbean, for the USA and Canada, and one expert consultation on juvenile justice.


Others:

Community policing handbooks: This project (a partnership between NEV-USP and the Special Secretariat for Human Rights and the European Union) produced a textbook to be used to train police officers and interested citizens to design and implement community policing. A draft of the handbook presented to focus groups in 6 state capitals: São Paulo, Belo Horizonte, Recife, Manaus, Campo Grande and Cuiabá for discussions with representatives from civil society and civil and military police officers. The handbook was reviewed as result of the focus groups discussions and a final version will shortly be available through the internet.

Cross referencing data from the newspaper data bases on lynching, death squads/execution groups and police violence: A pilot project to allow interactive access to cases of lynching, death/squads/execution groups and police violence to be made available to the general public. At present

researchers from NEV have access to the data and can carry out searches on the number of cases per state and for Brazil according with the type of violation involved and causes attributed to the cases. For São Paulo, users can retrieve the total number of cases per city, district, location, time of the day and police precinct where the case was recorded. This is the first step for an interactive use of the database. The system will be open to external users shortly.

Website NEV-Cidadão (guiadosdireitos): In 2008 this website was supposed to be expanded to the Metropolitan Region of São Paulo. An agreement was made with the Unesco Chair for City Management of the Methodist University of São Paulo and trainees were allocated to collect data from the Greater ABC municipalities to expand the website: São Bernardo, Santo André, São Caetano, Diadema, Mauá, Ribeirão Pires and Rio Grande da Serra¹. Data was collected and standardized to the model used for São Paulo and are in the process of being inserted in the existing web-site. In terms of the impact of the site in 2008 the number of visitors was record as expressed in the graph below:

Migration: At the end of 2007 the Incubadora virtual that hosted the site presented a number of technical problems resulting in services slowing down, as well as drop in quality. The decision was made to migrate the site to a private server, and to adopt Joomla as an open source management support. This led to a number of changes to be to the site. The new version will be accessible in March 2009 with the expanded data for the municipalities in the Greater ABC.



Website Safety and Citizenship: promotion of violence prevention and transparency in public security sector: In September 2008 one of NEV's researcher spent three weeks at the Institut National de Santé Publique du Québec, in Canadá, responsible for the development of the website *Centre québécois de ressources en promotion de la sécurité et en prévention de la criminal*, to identify the opportunities to transfer to Brazil this experience. This Mission led to the selection of themes and materials relevant to Brazilian reality and to the identification of potential funding sources, for the exchange (Canadian Mission to São Paulo to train the local staff, translation of documents, production of documents, editing and website development and maintenance). NEV presented a project to the Pan American Health Organization in February 2009.

Electronic periodical of NEV-USP, *Democracia, Direitos Humanos e Violência*: The layout and structure of the periodical website is ready and available at the address: www.nevusp.org/revista. The

editorial board has been established and the papers for the first issues have been subjected to peer reviewers. A mailing list of research groups and universities has been organized.

The full text news clippings that inform the data bases on gross human rights violations: During the last year all the 76.662 news clippings that had been scanned as images were included in an image data base. The mages had to be: mounted in a standard frame and, key words to identify the clippings attached to it as well as the number that the case covered in the clipping has in the human rights violations data base. The next phase of the work was to translate scanned images to text files. The first software used for this purpose proved unsatisfactory and we had to switch to FineReader 9.0. All news clippings referring to police abusive use of force for the state of São Paulo between 1999 and 2008 are in text form and trials are being made to use google like search mechanisms on this material.

Joint Program UNESCO Chair on Human Rights-IEA-USP/NEV: NEV organized in 2008 a number of activities with the UNESCO CHAIR on Human Rights: 1- the International Seminar on Torture, (also with the support of FAU/USP, IEA, CNPq and FAPESP and the State Board of Psychology Conselho Regional de Psicologia (SP) and the National Association for Post-graduated Studies in Human Rights (Associação Nacional de Pesquisa e Pós-graduação em Direitos Humanos- Andhep) and three lectures: a) Human Rights and Health (Direitos Humanos e Saúde) by Prof. Sofia Gruskin, Harvard University ,b) The promotion of human rights in Brazil: navigating in contradictions (Promoção dos Direitos Humanos no Brasil: navegando em contradições), by Prof. Paulo Sérgio Pinheiro and 3) Human Rights and the Brazilian Constitution: Advances and Challenges. (Direitos Humanos na Constituição Brasileira: avanços e desafios) by Prof. Sérgio Adorno.

2.3. Educational Activities in 2008

Course on Organizational Management in Public Security and Criminal Justice - The course was originally scheduled to start in February 2008 for two groups of 48 students each. The course consists of 18 lectures to be delivered by lecturers from the University of São Paulo (the School of Philosophy, Languages and Human Sciences, the School of Economics and Business, and the Polytechnic School), the Getulio Vargas Foundation, the São Paulo School of Public Prosecution University Candido Mendes, State University of Rio de Janeiro, Catholic University of Rio Grande do Sul and the World Bank, the Public Security Police of Setubal (Portugal) and the Centre National de la Recherche Scientifique

(France). Due to bureaucratic problems it started in mid-May and ended in September 2008. Besides lectures there were a number of fora for discussion of specific themes and students also had access to lecturers through special areas in the site for "chats". Three monitors followed the course throughout to help students when problems/difficulties emerged.

The 96 students that enrolled were selected by NEV-USP after an analysis of their curriculum vitae and statement in which they described what their expectations and needs were. Forty (40) officers from the Military Police, 40 Civil policemen, 15 prosecutors and 1 (one) judge enrolled. Similarly to the courses given at the University, judges showed little interest in this training. Remaining vacancies were allocated to policemen who represented greater demand for the course. In October the students were submitted to a written test at the University campus. Of the 96 students originally enrolled 87 concluded the course: 9 abandoned for different reason: workload or health problem. The students that did finish the course were: 37 military police officer, 36 civil policemen, 13 prosecutors and one judge.

3. MAJOR OBSTACLES/ SCIENTIFIC CHALLENGES

In 2008, while reporting on 2007, we stated that some of the challenges we faced were a direct consequence of the recency of the fields of and the lack of systematic investigations. We identified the following challenges:

- **a)** refine the indicators and the *m*ethodology to measure human rights, and develop indicators to compare Brazil with other countries.
- b) increase knowledge about mechanisms for the protection and promotion of access to human rights (civil, political, economic, social and cultural) in new democracies. Identify which factors weaken and which strengthen human rights in new democracies and the impact that policies to ensure universal access to human rights have on rule of law and on democracy.
- c) increase knowledge about the process of political re-socialization that should occur when transitions to democracy start: legacies from the authoritarian period and what is the impact that they have for rule of law, democracy and human rights.
- d) communicate, in a persuasive way, with civil society. As pointed by our International Advisory Committee we have to provide a more positive view of human rights. So far what we have had to communicate is mostly bad news, the challenge is to provide positive examples to carry out an exercise of how society should be if it were to be one in which human rights were universally applied.
- e) identify the relations between violence and human rights violations: when and/or what type of violence is related to (caused by?) human rights violations. The other challenge is to explore the connections between fear of violence and civil and political rights; what types of fear prevent the exercise of which rights.

Last year the dual exercise of preparing the research, education and knowledge transfer plan for the next three years and the elaboration of the proposal for the National Institute of Science and Technology allowed us to identify the progress we had made in items b, c and d and in the design of a research program that will help us advance in answers to item e. The opportunity presented by the National Institute is not without challenges as we have to learn to work in a network, with colleagues located in distant territories and with different, if complementary, history of research and intervention.

4. POTENTIAL PROBLEMS/BOTTLENECKS

In 2008 again while reporting on 2007 we highlighted that one of our major problems was access to official sources of the democracy that evolves in the country in terms of access that citizens have to information from official sources. We are not referring to information that is sensitive in terms of national security, but of archival information that in theory should be open to all: this continues to be a problem as access is erratic. As consequence we have seem that years of data collection efforts can be jeopardized and generalization of the findings limited by poor access to the information and or lack of rigor on the part of institutions to secure the retrieval of archival data can be retrieved. So researchers are caught between two pressures: on one hand there is a reticence on part of the authorities to disclose data, theoretically to protect the privacy of the involved and on the other when you are granted access you discover that the system of control the flow of documents (police inquests and the judicial process) is such that documents disappear with no trace.

The mixed quality of secondary data was, and continues to be, a problem that we will now explore in depth at local, state and federal level in the case of homicide. Data on violent offenses is politically very sensitive: it can be used to indicate success or failure of governmental policies.

Another problem pointed last year and that continues is the poor capacity we have to forecast how much time dissemination or knowledge transfer through the media will demand from researchers. We continue to have little control of part of the external demand as it is a consequence of events in society at large. We have greater control over external demands such as seminars or workshops promoted by other groups and for which we are invited. To cope with this we have been investing in using such opportunities for junior researchers to acquire more experience in presentations for external audiences, including abroad.

On the managerial side we pointed, in 2008 that there was the need institutionalize the Center to provide researchers with a career structure. We have taken measures to start the process of creating a proper Institute within the University opening negotiations with the Rector of the University and these are in an advanced state.

Lack of proper space continues to be a challenge, and again, we are negotiating for an extension of the built area so that we can accommodate the new activities of both, the new research program and that of the National Institute. Still there is no doubt that, despite the visibility and the capacity to bring research grants to the University, NEV is the least supported Center at the university, and this is clearly expressed in its almost primitive installations.

5. OBJECTIVES TO BE ACHIEVED IN 2009

5.1. Research

The research program is organized around three research lines. The research program proposes to explore the paradox of the unstable combination of changes and authoritarian continuities founded in Brazilian democratic transition and consolidation. At the broader level we seek to contribute to answer the question about what kind of democracy can develop in such complex contexts such as Brazil. This implies the study of the actual process of governance to identify in how far basic tenets of democracy are being respected. The focus will be on public security but we will also continue to monitor human rights in its full meaning giving at first priority to the right to physical integrity: to be protected from violence either by agents of the state or by others as key element to enjoy other rights. Governance is to be evaluated both by the actual results it produces in public security but also as how this performance is evaluated by the public and its effects on the development of a human rights culture and in the support for Rule of Law.

Line I) The implementation (or lack of) of democratic rule of law: public security or insecurity?

A group of core questions refers to the survival of states of un-rule of law, or the opposite of rule of law, in an otherwise democratic context. This can be interpreted as a symptom of the weakness of the institutions, and it is visible in the presence of systemic corruption within sectors of the civil service, within political parties and courts and by the growth organized crime and also in the institutions resistance to change. More recently some states have been the focus of investigations at all levels of government, due to evidence that corruption, fraud, and mismanagement of public funds were taking place amidst violence by state agents against the population and coercion of voters during elections. In two of these states parliamentary inquests and investigations by the Federal Police reported such breakdown in the respect of the laws promoted by local authorities as found in cases of "failed states". Representing cases of extreme condition of un-rule of law, covering two different periods in recent history, they constitute a privileged starting point to examine the impact that such extreme conditions have on citizen's support for democracy and for rule of law. They can teach us about whether the damage caused, by the state of near anarchy in local government, can be remedied once investigations take place and some punishment occurs. The cases of the states of Acre and Rondônia will be studied through the Project Violence and Frontiers (Violências e Fronteiras). The analysis will use multiple sources: official documents, parliamentary reports, court documents, coverage by the press, NEV's database, NGO's, interviews with significant informants, and survey with residents. For 2009 it will start with the results of Parliamentary inquiries that focused on these states will identify key political and economic processes that fed un-rule of law as well as to document the evolution of human rights violations in the last 30 years in both states as reported by human rights reports (including those from NEV) and by the media in the gross human rights violations database data base.

Line II) Public security, police performance and democratic political culture – the preconditions for a Human Rights Culture

Police investigation and judicial process in São Paulo: the case of homicides. One of the key institutions to ensure the protection of rights, and a key state actor in its opposite – the violation of human rights, is the police. The well functioning of this institution is fundamental to promote security to reduce fear and to secure the right to life. What role does impunity play for the development of human rights culture and in public support for democratic rule of law? This question is to be answered by the Project: Police investigation and judicial process in São Paulo: the case of homicides. (A Investigação Policial e o Processo Judicial do Crime de Homicídio no Município de São Paulo). The objectives of this project are to assess: 1- police work conditions (human and material resources) to investigate homicide cases; 2) work load and routines; 3) organizational culture (values, perceptions of perpetrators and victims, perception of how laws should be enforced, priorities for investigation, meaning of homicide, procedures for investigation, criteria for selection of cases to be investigated, etc.).

The analysis of factors that affect the institutional performance of the criminal justice system in the case of homicides will be based on technical reports, institutional evaluation documents, historical documents available at NEV's database (laws, norms, procedures, decrees that guide investigations and the judicial process) and qualitative data from interviews with members of the criminal justice system covering the same period as that of the actual cases of homicide2- the source of the data for the analysis of their performance (1991-1997).

At this stage a qualitative analysis of the 197 cases of homicide selected for the sample will be performed as soon as the statistical analysis is finished. The statistical analysis in course seeks to identify what factors explain the difference in outcomes of homicide cases: the role that social context and the judicial context play as well as that judicial and biographical profiles play in the outcomes. This analysis will help identify the legal and extra legal factors that contribute to impunity. Also this year a qualitative analysis of the data available (police inquests and judicial processes) will start. This will demand the digitalization of existing documents. Data from interviews with police officers, public prosecutors and judges on their perceptions of how homicide cases should be processed will also be analyzed (originally collected for

not (not guilty).

² Homicide cases that were the focus of the project "Assessment of the level of penal impunity (1991-1997)". This study revealed that high levels of impunity are in part due to the selectiveness of police investigators. Two variables were identified as explaining this selectiveness: known aggressor and whether the perpetrator was arrested in flagranti. Homicide cases that fell in one or another of the two conditions were more often object of a police inquiry. When cases are referred to prosecutors, and thus to courts, there is more formality and less selectiveness of law enforcement agents. This research has revealed the actual level of penal impunity; the identification of legal and extra-legal factors that explain the decision to archive cases and actual decision to punish (sentencing) or

the project *Continuidade Autoritária e Construção de Democracia*, NEV-USP entre 1994-1998, - www.nevusp.org). Finally an analysis of the rules and legislations that discipline the use of appeals in the criminal justice system will also be done.

Results expected for this year are: report to be disseminated through the institutional website of NEV and through papers to be submitted to periodicals in Brazil and abroad. Results will also be used for regular courses (undergraduate and post-graduated) at USP as well as in the e.learning courses specially designed for the police and members of the criminal justice system.

Feelings of impunity derive not only from the perception that cases are not properly investigated but also from the length of time between the reporting of the case and final sentencing. The project "Police investigation and judicial process in São Paulo: the case of homicides" will also focus on the length of time between the actual reporting of the cases and final sentencing. This is a much neglected theme in studies about the criminal judicial system in Brazil. The time of justice: its impact in the production of penal impunity will measure the time that it took for the different phases of the police inquiry and the penal process to be processed and analyze the relationship between this and its impact on penal impunity. In this first year the research will accomplish: a) an update of the literature on flow of justice as well as in justice tardiness; b) development of the analytical framework; c) organizations of the qualitative data (police inquiries and judicial process) for analysis.

II.a- Obstacles for a human rights culture

Democracy, Justice and Human Rights: Critical Theory Study Group. The group is to present a research proposal for the Brazilian Ministry of Justice to evaluate new proposals of legislative instruments of participative democracy. The expected results are the publication of papers in national and international journals, based on the analysis of data collected and the research material produced at the NEV. It will also participate in the publication of books; participate in Seminars and congresses of the area and in the organization of internal and external seminars. The Democracy, Justice and Human Rights: Critical Theory Studies group (DJDH) will dedicate two semesters of to study: a) Democracy, Environment and Human Dignity, and b) Democracy, Education for Human Rights. In each semester three activities will take place: discussions on the bibliography, definition of papers for discussion and an open seminar with presentations of the results of the research carried out during the semester.

Quasi longitudinal survey: exposure to violence and socially shared representations and attitudes to justice, rights and punishment and human rights

The impact that the performance of law enforcing agencies has on the public's trust in these institutions, in the legal framework as deterrents to the use of violence, and their effects on the public's support for the rule of law, and in particular their reactions to impunity will be measured by the sub-project *The quasi*

longitudinal survey study: exposure to violence and socially shared representations and attitudes to justice, punishment and human rights.

Many still believe that suspects of crimes are not entitled any form of protection including against torture, as force may be justified to contain crime at any cost. This is a sign of problems for a human rights culture to develop, as an effective democratic Rule of Law is essential for this culture. Public support for the Rule of Law is a powerful obstacle to the return of repressive measures. It is also an indicator that a civilizing process is in place. The capacity of authorities to enforce laws that are "non-retroactive, and in public knowledge universal, stable, predictable and non-ambiguous" or Rule of Law, is thus a pre-requisite for peaceful society.

If democracy and human rights culture demand the existence of effective democratic Rule of Law, what can be expected for the future of democracy in Brazil? What role does impunity play for the development of a human rights culture and in the support of democratic Rule of Law? What support do we find for the Rule of law among the population- what are the pre-conditions for a human rights culture? These questions we try to answer through this series of surveys, regularly applied by NEV since 2001 to residents in São Paulo, allows us to answer the questions concerning the obstacles to the development of a human rights culture, and to explore the role that fear and insecurity play in the resistance to the concept of universal access to human rights.

In this project the focus is on the role that exposure to violence (victimization) plays in socially shared representations, attitudes and values about justice, punishment and human rights; how such exposure affects their perception of their neighborhood and of public services- particular the quality of their experiences with law enforcement agencies and the expectations that they hold about future contacts, of social capital and civility within the community, of the causes of violence and in their acceptance or rejection of the use of violence as legitimate means to solve conflict and to discipline children.

Since youth are the most victimized age group, and also the group that has worse experience with law enforcement agencies, part of the survey explores youth's values and expectations for the future as well as the experiences of their peers as victims of violence. In 2009 we will concentrate in the statistical analysis of the data collected so far and in preparing a book on the violence and human rights and a series of papers on the relations between the experience of violence and attitudes to human rights.

The growth of homicide is interpreted as an indicator of the failure of the state and of democracy to reduce existing deprivations, and to improve access to rights (on the prevention side) and to, with full respect for rights and protections, repress by punishing those responsible for crimes (the deterrence side). What are the causes of the fall in homicide, specifically in the state of São Paulo? Why and how in

a context expansion of organized crime, corruption and gross human rights violations violence levels homicide is declining? "The fall of homicide in the state of São Paulo: a diagnosis of the magnitude and causes" and "Analysis of the fall in the homicide rate of youth in the city of São Paulo, 2000-2008": are complementary projects that address the questions listed above. The first will identify the size and the causes for the fall in homicide in the state, and will compare this to the homicide in key economic regions of the state: Campinas, Ribeirão Preto, Franca, São José do Rio Preto, Votuporanga, e Presidente Prudente, while the second project will focus on a specific age group in the city of São Paulo.

Official data on homicide will be collected from various sources: law enforcement agencies, Ministry of Health. Variables to be examined are: SES, age, gender, efficacy of the disarmament legislation (number of firearms apprehended), investments in public security, education, income, housing conditions (quality/crowding), labor (jobs per 10.000 residents) employment/unemployment rates, public policies for populations at risk such as: early closing of bars; improvements in communities that present overlapping deprivations and so forth. Data on gross human rights violations from NEV's databases will also be used to characterize communities (lynching, executions and use of force by the police). Furthermore data on violence prevention initiatives by NGO's will be collected from WHO's (World Health Organization) Inventory on Violence Prevention Initiatives identified in the State of São Paulo. Data on the independent variables will be collected for a longer period: 1980 to 2007 as the present fall in homicide may be a result of changes that accumulated over time. In 2009 all the secondary data necessary to test the hypothesis will be retrieved from all official sources and organized in a data base. Descriptive analysis with normality tests will be performed to prepare for multivariate analyses, as well as, for geo-statistics.

Line III) Monitoring Humans Rights

III.a- The present

Since we propose to explore the paradox of unstable combination of changes and continuities in Brazilian democracy, the study of the process of governance is a key element to identify in how far basic tenets of democracy are being respected. Governance is to be evaluated both by the actual results it produces in public security but also as how this performance is evaluated by the public and its effects on the development of a human rights culture and in the support for Rule of Law. Though the focus is on public security, we will continue to monitor human rights in its full meaning for even universal access to civil rights continue to be a challenge for democracy in Brazil. The links between the protection of human rights and public security policies are still weak as they remain perceived as autonomous spheres of governmental action.

To what extent human rights violations continue to occur in Brazil and who are the groups most at risk? This question we try to answer through the project "Monitoring Human Rights Violations". Since 1987 NEV monitors human rights violations in Brazil, through the systematic collection of data from official sources: the Census Bureau-IBGE, in their household surveys (PNADs), and data from public registrar office (birth and death), Ministry of Health, Ministry of Education, Ministry of Housing, Institute of Research and Applied Economics (IPEA), State Secretariat for Human Rights, FUNAI (National Indian Foundation), CIMI (Catholic Church Missionary Council for Indians), Human rights NGO's, reports on the profile of the criminal justice system, on human development, information on threats to the freedom of press from International Press Associations, on gross human rights violation using national newspapers as sources (Police Violence, Lynching and Executions), and so forth.

In 2009 this project is to edit and print the 4th National Report on Human Rights, to produce a balance of Police Violence in Brazil 20 years after the first studies on abusive use of force became public. Through this balance we hope to begin to answer some of the questions concerning the quality of democracy in Brazil for we are assuming that as suggested by Bayley "police activities are a barometer of the character of a regime".

We will identify: what has changed in terms of police use of lethal force, involvement in extra judicial killings, and torture and carry out a preliminary assessment of the efficacy of measures adopted so far to prevent the abusive use of force by the police: the transfer of jurisdiction of military police accused of homicide from military courts to civilian courts, the introduction of police ombudsoffices to improve external control over the police, the legislation to punish torture, changes in training, the introduction of human rights training in police academies and so forth. In so doing we will attempt to measure how the police forces react to reform and to democracy. This will result in a book and in series of papers.

III.b- The past

To what extent the lack of closure promoted by the general amnesty, a pre-condition for the transition to democracy is an obstacle to effective democratic rule of law? In other words can we have democratic rule of law while denying past violations? This question is to be answered by the project: **Mechanisms of extra-judicial reparation for victims of human rights violations: the Latin American experience:** During 2009, we will do a comparative study on the most representatives Truth Commissions in Latin-American States: Argentina, Chile and Peru. The analysis will include: (i) the historical aspects; (ii) the legitimacy and popular representation and (iii) the application of the mechanisms of truth, justice, reconciliation and reparations. Also each of the Truth Commissions will be analysed to identify: a) the breadth of the mandate of the Commissioners to investigate war crimes, torture, and terrorism committed by public agents according to their position in hierarchical military and power ranking; b) whether the

crimes against humanity and the genocide committed were or will be investigate by a Judicial Court; c) if hearings were open to the public in general; d) if the Commissioners had a mandate to investigate the causes of conflicts in their social, political, ideological and historical aspects, in order to contribute to the construction of a public and national memory and e) if Commissioners had a mandate to offer reparations to the victims, as well as public apologies in the name of the State.

Measuring the Effectiveness of Human Rights Campaigns in Latin America: the role of the Organization of American States Inter-American Commission on Human Rights, 1970-1985. In 1959, the OAS established the Inter-American Commission on Human Rights (IACHR). At first the IACHR promoted human rights by making recommendations to governments of member states, preparing studies or reports, urging member states to supply information on measures adopted by them in matters of human rights. This role changed dramatically after 1970 when the IACHR received petitions about human rights abuses committed by the Brazilian military dictatorship (1964-85). The dossiers about the torture of Brazilian political prisoners were so complete, and compelling, that the IACHR modified its past practice of merely advising countries and held that the Brazilian government was involved in the "gross violation of human rights." This new forum for the denunciation of torture in Latin America became particularly important after 1973 when the military came to power in Uruguay and Chile. Emboldened by the results of the Brazilian petitions, human rights activists, in these countries, appealed to the Commission. Hundreds of cases were filed, setting a precedent for the United Nations Human Rights Commission that until the late 1970s had been slow in responding to such cases. This pattern was to model the strategies of Human Rights Organization formed in the 1980's.

This study proposes to document the efficacy of petitioning such institutions by examining the history of the IACHR's response to the dramatic increase in human rights denunciations in the 1970s. We will measure the effectiveness of this approach through archival research and interviews with ex-Commissioners, lawyers, and former political prisoners. How successful was the IACHR in diminishing torture in Latin America? To what extent did these cases affect the human rights climate where violations occurred? Did international oversight made a difference? What are the implications for current debates about the use of torture? In the first year of the project, research team will analyze the Brazilian cases archived in Washington, D.C. and conduct interviews with former political prisoners in Brazil. The project is waiting for a clearance from the IACHR to have access to the archived documents.

Our participation in the two reports: Citizen Security and Human Rights in the Americas, and on Juvenile Justice in the Americas will continue with the regional consultations, in course, and the analysis of governmental responses to the questionnaires. The reports are scheduled to be launched at the end of 2010. The reports are being prepared under the coordination and supervision of Paulo Sergio Pinheiro, coordinator, CEPID/NEV/USP, with the cooperation and support of the Inter-American

Commission on Human Rights, the regional office of UNICEF TACRO and the regional office of the High Commissioner for Human Rights.

III.c - The future

Fostering healthy early development

This project aims at the reduction of violence, by improving the access that pregnant adolescents have to rights. It is based in the assumption that improved access to rights (for this age group: 0 to 18 years), enhances their chances for healthy development (physical, mental and emotional) and is a cornerstone for trust to evolve. This means not only trust in others, but also trust in the system: in laws, in rights and duties and thus rules and this in turn are pre-conditions for a culture of respect for human rights and part of the civilizing process. The Brazilian state still fails to ensure full access, of the needlest groups, to basic rights. Not even the right to citizenship is secured, given that between 30% to 5% of the children born number in the country each year, are not officially registered. Without a birth certificate they are excluded from any access to rights. The poorest and least educated groups are the most affected by lack of universal access to rights and pregnant adolescents are at a greater risk of passing this exclusion to a new generation.

In 2009 the development of home visitation protocols will continue with: a) pre-test of the protocols with adolescents and their families in São Paulo and in Porto Alegre, b) refinement and pre-test of the protocols to train home visitors, c) advance in negotiations with the state secretariats of Health of São Paulo and Rio Grande do Sul for future transfer of the methodology and advance in the development of tools to evaluate the pilot experiment. A pre-test of the methodology will be carried out with 10 pregnant adolescents in São Paulo and 10 in Porto Alegre.

Evaluation of the program fostering healthy early development. Protocols for the quantitative evaluation of the pilot experiment are nearly finished, along 2009 the team will develop the qualitative tools that will be used. Both quantitative and qualitative tools will be pre-tested in the field along with the pre-pilot that is to take place.

5.2. Knowledge transfer

5.2.1 Websites

NEV's Institutional website: The new version of the site will be available along with the site for the National Institute of Science and Technology. Reports and unpublished manuscripts from NEV are being

digitalized to be made available in the new site for downloads. A new area for videos and audios will be available this year.

NEV-Cidadão (guiadosdireitos), (NEV-Citizen): The site supported by Joomla, with a new design and with data on the Metropolitan Region of São Paulo will be launched. The area with information about rights and public services will be enlarged. There will be more emphasis in disseminating information about the site in areas such as internet areas in community centres and in public schools. Also improve the accessibility and user friendliness through a user's satisfaction survey.

Youth rights' guide website: A website will be developed together with middle and high school students from public schools on children's rights and on citizenship rights, to be used in their daily activities. This website will be built initially involving 4 middle schools in São Paulo. The audience is that of all youth with access to the internet. The development of the website will be in situ using the infra-structure of the schools. The Institute will coordinate the project and train the students to use necessary tools. Drawing from the experience NEV had with Youth Human Rights Observatories and Reports we will encourage youth to translate human rights and citizenship rights to useful information for their day to day and that of their communities. It is expected that this project will: 1- raise their awareness about democracy and human rights; 2- encourage critical thought; 3- encourage involvement in community issues and raise their awareness about the public sphere; 4- increase civility; 5- improve their access to the social protections present in the Estatuto da Criança e do Adolescente; 6- provide them with skills in electronic media; 7- promote greater social activism among youth and 8- encourage the exercise of citizenship rights.

Safety and Citizenship website: promoting violence prevention and transparency in the public security domain. In 2009 we will: a) update the Brazilian literature on the themes covered by the site; b) select, translate and adapt international literature; c) prepare texts on the themes selected; d) continue the development of the structure and content of the website; e) implement and maintain the website.

Website of the National Institute of Science and Technology: Violence, Democracy and Citizen Security: A website containing information about the Institute' composition, research, education and knowledge transfer program is being designed and will be available in March 2009.

Digital Human Rights Violations database: In 2009 we will open access to the public to the image data base with the total of scanned news clippings images (65.334 clippings). It is expected that 40.000 clippings will be transformed into text in the coming months, and that the remaining 20.000 will be ready in the first semester of 2010. The software that allows for more complex searches of the text material is

ready and will be open for internal users in the next three months. Researchers will have access to the cases in the data bases as soon as they are transcribed into text files.

e.journal- Two editions will be prepared this year.

5.2.2 Seminars

With CEM (Centro de Estudos da Metrópole) NEV will hold a series of seminars to discuss the role of the *Labor market- informal/illegal/legal in violence and crime* and in particular the connections with and opportunities for organized crime.

Truth Commissions, Amnesties and Accountability: what the recent history of Latin America can teach Brazil. An International seminar to debate: the role of amnesty in the right to memory, and transitional justice.

5.2.3 Other

NEV-Unesco Chair on Human Rights Education: NEV will continue to collaborate with the Unesco Chair for Human Rights to optimize the efforts by both institutions.

5.3. Education

As programmed in the activities of the National Institute teaching will be strengthen as well as cosupervision through: a) joint courses in situ and through courses delivered by the internet (e.learning); b) exchange of lecturers and researchers to teach short term courses between partner institutions, also as means to increase interaction and dialogue between researchers, lecturers and students; c) exchange of post-graduated students among partner institutions to diversify and enrich their training experience, both to participate in field work and in courses; d) monthly video conference by researchers and post-graduate degree students to be shared by all partners, followed by debate. These video conferences will be taped so that they can be retrieved and reviewed by partners as well as made available to the general public via partners' sites.

The courses to be shared by the partners will offer disciplines exploring the following contents: democracy, human rights and Rule of Law: democratization, globalization and organized crime; theoretical models to explain violence and crime in contemporary societies (organized crime, interpersonal violence, family violence with special emphasis on gender, race and age issues); democracy, lynching, extra judicial executions and hired killings; reform of public security policies and criminal justice- in particular juvenile justice; police reform and organizational culture (in particular the

impact over professional identities; and human rights (history and evolution). Another line of course will be aimed at methodological issues such as: a) sources to study democracy, violence and crime, Rule of Law, and cultural change (archival, historical, data series, collective and institutional memories, governmental and non-governmental reports); methods to study human rights, Rule of Law, cultural change, violence and crime in particular organized crime- developing data bases, using computerized techniques for qualitative data analysis, analysis of data series, and longitudinal data, geo-statistics, data collection techniques, surveys, interviews, focus groups, observational methods). A special course on scientific language applied to the social sciences will be designed to improve the performance of higher degrees candidates in writing papers for publication.

Short courses on monitoring human rights: week long course to refine methods and indicators to monitor human rights, to promote dialogue between officials in charge of producing social indicators, human rights scholars and activists on methods and indicators to assess the state of human rights and finally to develop teaching tools to be used in future e.format courses. Secondary objectives include: update the debate on means to monitor human rights, improve existing methods and indicators, promote the exchange of international and expertise on human rights monitoring and researching.

Statisticians and researchers will be invited to lecture for a week for an audience of Brazilian researchers and public officials from local, state and federal departments in charge of social and economic, cultural and environmental data as well as from the criminal justice system, from other human rights organizations and academic researcher sin this field. The week long courses will be distributed along the next three years. Lecturers will be invited to present a paper for publication and the lectures will be filmed for future adaptation to e.format.

Short term course to review the Authoritarian Personality: The Frankfurt School and Habermas: Obstacles to the development of a human rights culture- what tools can education provide to reinforce a greater acceptance for human rights? How can education foster tolerance, respect for pluralism and citizen participation in political life? What role can the arts, education and media play in the transformation of culture? Based on the contributions from J. Habermas and A. Honneth this series of seminars for Law students will address the obstacles to the development of a human rights culture. The seminars will be carried out in partnership with the International Group for the Study of Critical Theory at the Institute of Social Research coordinated by Axel Honneth.

Course on Organizational Management in Public Security and Criminal Justice: This course was selected to be regularly available through the Virtual University of the State of São Paulo- UNIVESP directed at the same public: civil and military police officers, public prosecutors and judges.
