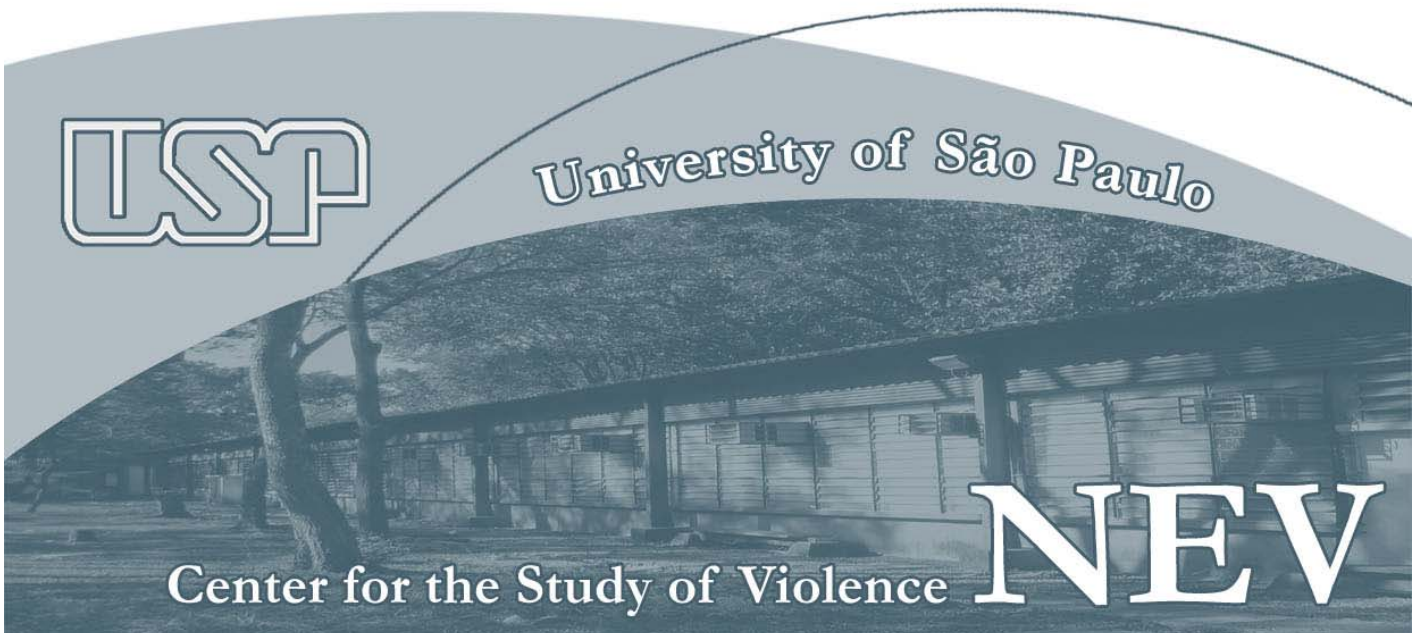

1. SUMMARY DESCRIPTION OF PROPOSED ACTIVITIES FOR 2009

1.1. Research:

The research program was to explore the paradox of the unstable combination of changes and authoritarian continuities founded in Brazilian democratic transition and consolidation by continuing efforts to answer the question about what kind of democracy can develop in such complex contexts such as Brazil. To do so we chose to study the actual process of governance to identify in how far basic tenets of democracy are being respected. The focus is on public security while monitoring human rights, in its full meaning giving, though granting priority to the right to physical integrity: to be protected from violence either by agents of the state or by others as key element to enjoy other rights. Governance is being evaluated both by the actual results it produces in public security but also as how this performance is evaluated by the public and what effects (if any) on the development of a human rights culture and in the support for Rule of Law.

Line 1. The implementation (or lack of) of democratic rule of law: public security or insecurity?

A group of core questions refers to the survival of states of un-rule of law, or the opposite of rule of law, in an otherwise democratic context. This can be interpreted as a symptom of the weakness of the institutions, and it is visible in the presence of systemic corruption within sectors of the civil service, within political parties and courts and by the growth of organized crime and also in the institutions resistance to change. Two states that were the object of parliamentary inquests and investigations by the Federal Police and that reported such breakdown in the respect of the laws promoted by local authorities to a point in which they appear to be examples of “failed states” are the object of study. Representing cases of extreme condition of un-rule of law, covering two different periods in recent history, they constitute a privileged starting point to examine the impact that such extreme conditions have on citizen’s support for democracy and for rule of law. It is expected that we can learn how after living in a state of near anarchy promoted by local government, damages to trust in democracy can be remedied, and what role law enforcement plays in this healing process. The cases of the states of Acre and Rondônia are being studied through the Project Violence and Frontiers (*Violências e Fronteiras*). The analysis uses multiple sources: official

documents, parliamentary reports, court documents, coverage by the press, NEV's database, NGO's, interviews with significant informants, and survey with residents. For 2009 it was expected that we retrieved the results of Parliamentary inquiries that focused on these states, identifying key political and economic processes that fed un-rule of law. The evolution of human rights violations in the last 30 years in both states as reported by human rights reports (including those from NEV) and by the media in the gross human rights violations database will also be analyzed.

Line 2. Public security, police performance and democratic political culture – the preconditions for a Human Rights Culture

L2.a. Police investigation and judicial process in São Paulo: the case of homicides

One of the key institutions to ensure the protection of rights, and a key state actor in its opposite – the violation of human rights, is the police, a key institution to promote security, to reduce fear and to secure the right to life. What role does impunity play for the development of human rights culture and in public support for democratic rule of law? This question is to be answered by the present project. Its objectives are to assess: 1) police work conditions (human and material resources) to investigate homicide cases; 2) work load and routines; 3) organizational culture (values, perceptions of perpetrators and victims, perception of how laws should be enforced, priorities for investigation, meaning of homicide, procedures for investigation, criteria for selection of cases to be investigated, etc.).

The analysis of factors that affect the performance of the criminal justice system, specifically in the case of homicides, is based on technical reports, institutional evaluation documents, historical documents available at NEV's database (laws, norms, procedures, decrees that guide investigations and the judicial process) and in qualitative data from interviews with members of the criminal justice system, covering the same period of the actual cases of homicide¹, the source of data for the analysis of their performance (1991-1997).

The 197 cases of homicide, selected for the sample, were to undergo a qualitative

¹ Homicide cases that were the focus of the project: "Assessment of the level of penal impunity (1991-1997)". This study revealed that high levels of impunity are in part due to police discretion. Two variables were identified as explaining police investigative selectivity: identity of the aggressor known when case was reported ("known aggressor") and when the perpetrator was arrested at the scene ("in flagranti"). Homicide cases that fell in one or another of the two conditions were more often object of a police inquiry. When cases are referred to prosecutors, and thus to courts, there is more formality and less selectivity.

analysis. The statistical analysis sought to identify what explained differences in the outcome of homicide cases: the role that social context and the judicial context play, as well as that of the biographical profiles of the agents involved play in the outcome. This analysis will help to identify the legal and extra legal factors that contribute to impunity. The qualitative analysis of the data available (police inquests and judicial processes) was to start in 2009. This would demand that court documents be digitalized. Data from interviews with police officers, public prosecutors and judges on their perceptions of how homicide cases should be processed will also be analyzed (originally collected for the project *Continuidade Autoritária e Construção de Democracia*, NEV-USP entre 1994-1998, [-www.nevusp.org](http://www.nevusp.org)). An analysis of the rules and legislations that discipline the use of appeals in the criminal justice system was another key activity to be carried out.

Results expected for 2009 were: report to be disseminated through the institutional website of NEV and through papers to be submitted to periodicals in Brazil and abroad. Results will also be used for regular courses (undergraduate and post-graduated) at USP as well as in the e.learning courses specially designed for the police and members of the criminal justice system.

Since feelings of impunity derive not only from the perception that cases are not properly investigated but also from the length of time between the reporting of the case and final sentencing. The sub project **The time of justice: its impact in the production of penal impunity** was to focus on the length of time between the actual reporting of cases and final sentencing. A neglected theme in studies about the criminal judicial system in Brazil, the time that it took the police to process the inquiry and the time the judiciary took to try the cases and its impact on penal impunity are the object of this subproject. In 2009 this analysis was to: a) an update literature review on flow of justice as well as on justice tardiness; b) develop the qualitative analysis framework; c) prepare qualitative data (police inquiries and judicial process) for analysis.

L2.b. Obstacles for a human rights culture

Democracy, Justice and Human Rights: Critical Theory Study Group. The study group was to present a research proposal for the Brazilian Ministry of Justice to evaluate proposals for new legislative instruments to ensure participative democracy. Expected results were the publication of papers in national and international journals, based on the analysis of data collected and the research material produced at NEV. The study group was to participate in the publication of books, in Seminars and Congresses in the area and in the

organization of internal and external seminars. The Democracy, Justice and Human Rights: Critical Theory Studies Group (DJDH) was to dedicate two semesters to study: a) Democracy, Environment and Human Dignity, and b) Democracy and Education for Human Rights. At each semester three activities were to take place: discussions on the bibliography, definition of papers for discussion and open seminars with presentations of the results of the research carried out during the semester.

Quasi longitudinal survey: exposure to violence and socially shared representations and attitudes to justice, rights and punishment and human rights. The impact that the performance of law enforcing agencies has on the public's trust in these institutions, in the legal framework as deterrents to the use of violence, and in their effects on the public's support for the Rule of Law, and in particular, their reactions to impunity is being measured in this project. What role does impunity play for the development of a human rights culture and in the support of democratic Rule of Law? What support do we find for the Rule of Law among the population- what are the pre-conditions for a human rights culture? These questions we try to answer through this series of surveys, regularly applied by NEV since 2001 to residents in São Paulo, allows us to answer the questions concerning the obstacles to the development of a human rights culture, and to explore the role that fear and insecurity play in the resistance to the concept of universal access to human rights.

In this project the focus is on the role that exposure to violence (victimization) plays in socially shared representations, attitudes and values about justice, punishment and human rights; how such exposure affects their perception of their neighborhood and of public services- in particular the quality of their experiences with law enforcement agencies, and the expectations they hold about future contacts with law enforcement, of social capital and civility within the community, of the causes of violence and in their acceptance or rejection of the use of violence as legitimate means to solve conflict and to discipline children. Since youth are the most victimized age group, and also the group that has worse experience with law enforcement agencies, part of the survey explores youth's values and expectations for the future, and their peers experiences of victimization. In 2009 the focus was to be in the statistical analysis of the data collected, and in preparing a book on the violence and human rights and a series of papers on the relations between the experience of violence and attitudes to human rights.

The growth of homicide is interpreted as an indicator of the failure of the state and of democracy to reduce existing deprivations, and to improve access to rights (on the prevention side) and to, with full respect for rights and protections, repress by punishing

those responsible for crimes (the deterrence side). What are the causes of the fall in homicide, specifically in the state of São Paulo? *Why* and *how* in a context of expansion of organized crime, corruption and gross human rights violations, homicide is declining? **“The fall of homicide in the state of São Paulo: a diagnosis of the magnitude and causes”** and **“Analysis of the fall in the homicide rate of youth in the city of São Paulo, 2000-2008”**: are complementary projects that address the questions listed above. The first is to identify the size and the causes for the fall in homicide in the state, and was to compare state rates to those in key economic regions of the state: Campinas, Ribeirão Preto, Franca, São José do Rio Preto, Votuporanga, and Presidente Prudente, while the second project was to focus on a specific age group in the city of São Paulo.

Official data on homicide was to be collected from various sources: law enforcement agencies and from the Ministry of Health. Variables that were to be examined were: SES, age, gender, efficacy of the disarmament legislation (number of firearms apprehended), investments in public security, education, income, housing conditions (quality/crowding), labor (jobs per 10.000 residents), employment/unemployment rates, public policies for populations at risk such as: early closing of bars; improvements in communities that present overlapping deprivations, violence prevention programs, programs to prevent substance abuse and so forth. Data on gross human rights violations from NEV’s databases would be used to characterize communities (lynching, executions and use of force by the police). The project was to use data collected by WHO’s (World Health Organization) through the Inventory on Violence Prevention Initiatives identified in the State of São Paulo. Data on the independent variables were to be collected for a longer period: 1980 to 2007 as the present fall in homicide may be a result of changes accumulated over time. In 2009 all the secondary data necessary to test the hypothesis would be collected from official sources and organized in a data base. Descriptive analysis with normality tests would be performed to prepare for multivariate analyses, as well as, for geo-statistics.

Line 3. Monitoring Human Rights

L3.a. Human Rights: The Present

To what extent human rights violations continue to occur in Brazil and who are the groups most at risk? This question we try to answer through the project *“Monitoring Human Rights Violations”*. Since 1987 NEV monitors human rights violations in Brazil, through the systematic collection of data from official sources: the Census Bureau-IBGE, in their household surveys (PNADs), and data from public registrar office (birth and death), Ministry

of Health, Ministry of Education, Ministry of Housing, Institute of Research and Applied Economics (IPEA), State Secretariat for Human Rights, FUNAI (National Indian Foundation), CIMI (Catholic Church Missionary Council for Indians), Human rights NGO's, reports on the profile of the criminal justice system, on human development, information on threats to the freedom of press from International Press Associations, on gross human rights violations using national newspapers as sources (Police Violence, Lynching and Executions), and so forth.

In 2009 the 4th National Report on Human Rights, was to be finalized and edited, and twenty year balance on Police Violence in Brazil made. This balance was necessary to explore one of the questions concerning the quality of democracy in Brazil, inspired by Bayley² (1990) "police activities are a barometer of the character of a regime". This balance would be aimed at the identification of: what has changed in terms of police use of lethal force, involvement in extra judicial killings, and torture. A preliminary assessment of the efficacy of the measures³ adopted, so far, to prevent abusive use of force by the police would be carried out to explore means to measure how the police forces react to reform and to democracy. This would result in a book and in series of papers.

L3.b. Human Rights: The Past

To what extent the lack of closure promoted by the general amnesty, a pre-condition for the transition to democracy is an obstacle to effective democratic rule of law? In other words can we have democratic rule of law while denying past violations? This question is to be answered by the project: **Mechanisms of extra-judicial reparation for victims of human rights violations: the Latin American experience:** During 2009, we were to do a comparative study on the most representatives Truth Commissions in Latin-American States: Argentina, Chile and Peru. The analysis includes: (i) historical context; (ii) the legitimacy and citizen participation and (iii) the application of the mechanisms of truth, justice, reconciliation and reparations. Each of the Truth Commission was to be analyzed in terms of: a) the breadth of the mandate of the Commissioners to investigate war crimes, torture, and terrorism committed by public agents according to their position in hierarchical military and power ranking; b) whether the crimes against humanity and the genocide committed were or will be investigate by a Judicial Court; c) if hearings were open to the public in general; d) if

the Commissioners had a mandate to investigate the causes of conflicts in their social, political, ideological and historical aspects, in order to contribute to the construction of a public and national memory and e) if Commissioners had a mandate to offer reparations to the victims, as well as public apologies in the name of the State.

Measuring the Effectiveness of Human Rights Campaigns in Latin America: the role of the Organization of American States, the Inter-American Commission on Human Rights, 1970-1985. In 1959, the OAS established the Inter-American Commission on Human Rights (IACHR). At first the IACHR promoted human rights by making recommendations to governments of member states, preparing studies or reports, urging member states to supply information on measures adopted by them in matters of human rights. This role changed dramatically after 1970 when the IACHR received petitions about human rights abuses committed by the Brazilian military dictatorship (1964-85). The dossiers about the torture of Brazilian political prisoners were so complete, and compelling, that the IACHR modified its past practice of merely advising countries and held that the Brazilian government was involved in the “gross violation of human rights.” This new forum for the denunciation of torture in Latin America became particularly important after 1973 when the military came to power in Uruguay and Chile. Emboldened by the results of the Brazilian petitions, human rights activists in these countries, appealed to the Commission. Hundreds of cases were filed, setting a precedent for the United Nations Human Rights Commission that until the late 1970s had been slow in responding to such cases. This pattern was to model the strategies of Human Rights Organization formed in the 1980’s.

This study proposed to: a) document the efficacy of petitioning such institutions by examining the history of the IACHR’s response to the dramatic increase in human rights denunciations in the 1970s; b) measure the effectiveness of this approach through archival research and interviews with ex-Commissioners, lawyers, and former political prisoners to reduce torture and to reduce human rights violations and c) did the measures have lasting impact for instance on the use of torture? The research team was to analyze the Brazilian cases archived in Washington, D.C. and conduct interviews with former political prisoners in Brazil. The project was waiting for a clearance from the IACHR to have access to the archived documents.

Our participation in the two reports: **Citizen Security and Human Rights in the Americas**, and on **Juvenile Justice in the Americas** was to continue with the regional consultations, in course, and the analysis of governmental responses to the questionnaires. The reports are scheduled to be launched at the end of 2010. The reports are being

prepared under the coordination and supervision of Paulo Sergio Pinheiro, coordinator, CEPID/NEV/USP, with the cooperation and support of the Inter-American Commission on Human Rights, the regional office of UNICEF TACRO and the regional office of the UN High Commissioner for Human Rights.

L3.c. Human Rights: The Future

Fostering healthy early development. This project aims at the reduction of violence, by improving the access that pregnant adolescents have to rights. It is based in the assumption that improved access to rights (for this age group: 0 to 18 years), enhances their chances for healthy development (physical, mental and emotional) and is a cornerstone for trust to evolve. This means not only trust in others, but also trust in the system: in laws, in rights and duties and thus rules. These in turn, are pre-conditions for a culture of respect for human rights and part of the civilizing process. The Brazilian state still fails to ensure full access, of the neediest groups, to basic rights. Not even the right to citizenship is secured, given that between 30% to 5% of the children born, in the country each year, are not officially registered. Without a birth certificate they are excluded from any access to rights. The poorest and least educated groups are the most affected by lack of universal access to rights and pregnant adolescents are at a greater risk of passing this exclusion to a new generation. In 2009 the development of home visitation protocols was to continue with: a) pre-test of the protocols with adolescents and their families in São Paulo and in Porto Alegre, b) refinement and pre-test of the protocols to train home visitors, c) advance in negotiations with the state secretariats of Health of São Paulo and Rio Grande do Sul for future transfer of the methodology and advance in the development of tools to evaluate the pilot experiment. A pre-test of the methodology will be carried out with 10 pregnant adolescents in São Paulo and 10 in Porto Alegre.

Evaluation of the program fostering healthy early development. In 2009 the team was to develop the qualitative tools to be used in the evaluation. Both quantitative and qualitative tools were to be pre-tested in the field along with the pre-pilot that was to take place.

1.2. Knowledge transfer

1.2.1. Web-sites

- **NEV's Institutional website:** The new version of the site along with the site for the National Institute of Science and Technology was to be made available. Reports and unpublished manuscripts from NEV newly digitalized were to be made available in the new site for downloads. A new area for videos and audios would also be available this year.

- **NEV-Cidadão (guiadosdireitos), (NEV-Citizen):** The site supported by Joomla, with a new design and with data on the Metropolitan Region of São Paulo was to be launched. The area with information about rights and public services was to be enlarged. There was to be more initiative to disseminate information about the site in areas such as internet areas in community centers and in public schools. The accessibility and user friendliness was to be improved through a user's satisfaction survey.

- **Youth rights' guide website:** A website was to be developed together with middle and high school students from public schools on children's rights and on citizenship rights, for use in their daily activities. This website was to be developed in partnership with 4 middle schools in São Paulo. The audience is that of all youth with access to the internet. The development of the website was to be in situ, using the infra-structure of the schools. NEV would coordinate the project and train the students to use necessary tools. Drawing from the experience NEV had with Youth Human Rights Observatories and Reports we would encourage youth to translate human rights and citizenship rights to useful information for their day to day and that of their communities. It is expected that this project will: 1- raise their awareness about democracy and human rights; 2- encourage critical thought; 3- encourage involvement in community issues and raise their awareness about the public sphere; 4- increase civility; 5- improve their access to the social protections present in the Estatuto da Criança e do Adolescente (Child's Charter of Rights); 6- provide them with skills in electronic media; 7- promote greater social activism among youth and 8- encourage the exercise of citizenship rights.

- **Safety and Citizenship website: promoting violence prevention and transparency in the public security domain:** In 2009 we were to : a) update the Brazilian literature on the themes covered by the site; b) select , translate and adapt international literature; c) prepare texts on the themes selected; d) continue the development of the structure and content of the website; e) implement and maintain the website.

- **Website of the National Institute of Science and Technology: Violence, Democracy and Citizen Security:** A website containing information about the

Institute's composition, research, education and knowledge transfer program was to be available in March 2009.

- **Digital Human Rights Violations database:** In 2009 we were to open access to the public to the image data base with the total of scanned news clippings images (65.334 clippings). It was expected that 40.000 clippings were transcribed to text in the coming months, and that the remaining 20.000 will be ready in the first semester of 2010.
- **E.journal:** Two editions were to be prepared this year.
- **NEV-Unesco Chair on Peace, Human Rights, Democracy and Tolerance Education:** NEV was to continue to collaborate with the Unesco Chair for Human Rights to optimize the efforts by both institutions.

1.2.2. Seminars

- NEV was to hold a series of seminars with CEM (Center for Metropolitan Studies) to discuss the role of the **Labor market- informal/illegal/legal in violence and crime**, in particular the connections with, and opportunities for organized crime.
- **Truth Commissions, Amnesties and Accountability: what the recent history of Latin America can teach Brazil?.** An International seminar to debate: the role of amnesty in the right to memory, and transitional justice.

1.3. Education

- **National Institute (INCT):** As programmed in the activities of the National Institute (INCT), teaching and as well as co-supervision were to be strengthened through: a) joint courses in situ and through courses delivered by the internet (e.learning); b) exchange of lecturers and researchers to teach short term courses between partner institutions, also as means to increase interaction and dialogue between researchers, lecturers and students; c) exchange of post-graduated students among partner institutions to diversify and enrich their training experience, both to participate in field work and in courses; d) monthly video conference by researchers and post-graduate degree students to be shared by all partners, followed by debate. These video

conferences were to be taped so that they can be available to the general public via partners' sites.

The courses to be shared by partners were to offer disciplines exploring the following contents: Democracy, Human Rights and Rule of Law; Democratization; Globalization and organized crime; Theoretical models to explain violence and Crime in contemporary societies (organized crime, interpersonal violence, family violence with special emphasis on gender, race and age issues); democracy, lynching, extra judicial executions and hired killings; reform of public security policies and criminal justice- in particular juvenile justice; police reform and organizational culture (in particular the impact over professional identities; and human rights (history and evolution). Another line of course was aimed at methodological issues such as: a) sources to study democracy, violence and crime, Rule of Law, and cultural change (archival, historical, data series, collective and institutional memories, governmental and non-governmental reports); methods to study human rights, Rule of Law, cultural change, violence and crime in particular organized crime- developing data bases, using computerized techniques for qualitative data analysis, analysis of data series, and longitudinal data, geo-statistics, data collection techniques, surveys, interviews, focus groups, observational methods). A special course on scientific language applied to the social sciences was to be designed to improve the performance of higher degrees candidates in writing papers for publication.

- **Short courses on monitoring human rights:** week long course to refine methods and indicators to monitor human rights, to promote dialogue between officials in charge of producing social indicators, human rights scholars and activists on methods and indicators to assess the state of human rights and finally to develop teaching tools to be used in future e.format courses. Secondary objectives included: update the debate on means to monitor human rights, improve existing methods and indicators, promote the exchange of international and expertise on human rights monitoring and researching. Statisticians and researchers were to be invited to lecture for a week for an audience of Brazilian researchers and public officials from local, state and federal departments in charge of social and economic, cultural and environmental data as well as from the criminal justice system, from other human rights organizations and academic researchers in this field. The week long courses were to be distributed along the next three years. Lecturers will be invited to present a paper for publication and the lectures will be filmed for future adaptation to e.format.

- **Short term course to review: The Authoritarian Personality:** The Frankfurt

School and Habermas: Obstacles to the development of a human rights culture- what tools can education provide to reinforce a greater acceptance for human rights? How can education foster tolerance, respect for pluralism and citizen participation in political life? What role can the arts, education and media play in the transformation of culture? Based on the contributions from J. Habermas and A. Honneth, this series of seminars for Law students was to address the obstacles for the development of a human rights culture. The seminars will be carried out in partnership with the International Group for the Study of Critical Theory at the Institute of Social Research coordinated by Axel Honneth.

- **Course on Organizational Management in Public Security and Criminal Justice:** This course was selected to be regularly available through the Virtual University of the State of São Paulo- UNIVESP directed at the same public: civil and military police officers, public prosecutors and judges.

2. QUALITATIVE ANALYSIS OF THE PROPOSED ACTIVITIES FOR 2009

Activities programmed for this period were to contribute to answer the key questions proposed in the research program through three research lines: **a) The implementation (or lack of) of democratic rule of law: public security or insecurity? b) Public security, police performance and democratic political culture – the preconditions for a culture of human rights, and c) Monitoring Humans Rights – the present, past and future.** The focus of the research is in the quality of democracy under construction in the country, in particular the quality of governance with priority being given to two themes: public security and access to rights. Governance being evaluated both by the actual results it produces in public security and through how this performance is evaluated by the public, and its effects on the development of a human rights culture and in the support for Rule of Law. Specifically we want to answer the following questions:

- Why improvements in economic and social rights, in a context of decline of fatal violence, co-exist with the expansion of organized crime, corruption and gross human rights violations?
- Why, despite improvements, territories dominated by organized crime continue to exist (and even grow), and systemic corruption continues to plague the political, administrative, and judicial spheres?
- Can there be public security without universal access to civil rights, in particular to the right to life?
- What role does impunity play for the development of a human rights culture and in the support of democratic Rule of Law (Morlino, 2004)? What are the pre-conditions for a human rights culture?
- To what extent human rights violations continue to occur in Brazil and who are the groups most at risk?
- To what extent the lack of closure promoted by the general amnesty, a pre-condition for the transition to democracy is an obstacle to effective democratic rule of law? In other words can we have democratic rule of law while denying past violations?

- If democracy and a human rights' culture demand the existence of effective democratic Rule of Law, what can be expected for the future of democracy in Brazil?

Answers to these questions are being sought in different research projects. The projects vary in terms of breadth, research design, methodology, type of data collected and sources used. The INCT Violence, Democracy and Citizen Security (CNPq-FAPESP), provides the opportunity for greater breadth to the studies both in terms of the territory covered (numerous states, instead of São Paulo alone), as well as of depth, as now police forces are being analyzed from multiple perspectives, with contributions from various fields. At first, only two projects had national coverage: Monitoring Human Rights, through the National Reports on Human Rights that collects and processes data from every state in the Federation, as well as the Federal District, and the survey in 10 state capitals, now enlarged to cover 11 state capitals. The study on Violence and Frontiers that focuses on two frontier states: Acre and Rondônia. The creation of the INCT and the partnerships that it entails systematic comparisons between regions and states will be possible, granting greater density to the analysis of the relations between public security governance, access to rights, culture of human rights and organized crime not only across the country but also with some countries in Latin America (Argentina, Colombia, Mexico and Chile).

The various research projects have two axes in common: access to rights (civil, political, economic, social, cultural) and access to justice. In the later salience is given to the role that justice plays in ensuring the right to life. The research projects concerned with access to rights collect data that vary from more general aspects to more particular ones, they move from describing general conditions of regions and states in the country to what happens in large cities within a state to the dynamics of families at greater risk for violent victimization and violation of human rights. A similar process takes place in projects that focus on access to justice: departing from descriptive data about the system the goal is to arrive at the analysis of the performance of criminal justice agents in cases of homicide. A continued key challenge in this process has been access to sources of data to answer the questions posed. A second challenge has been to integrate data from various sources due to differences in: data collection and storing; standards of data quality; potential to disaggregate data to analyze smaller parts of the territory, for instance some very interesting data cannot be broken down to be used to analyze census tracts, for instance.

During the past year researchers concentrated in data treatment and analysis collecting only data to complement analyses. The process of combining secondary data from different

sources was very time consuming. Numerous problems were identified in the secondary data sets that demanded contacts with the original sources to clear doubts and/or correct errors of categorization, for instance errors in census tracts codes that prevented comparisons across time, criminal offenses that were wrongly labeled and so forth. Exploratory statistical analyses were also carried out. Their results also required that we reviewed our own data bases. Data consistency checks besides being laborious encouraged a turn over of research assistants involved in this task resulting in extra efforts for recruiting and re-training.

This effort was worthwhile as now there is more confidence in the quality of the data bases and more the integration between projects evolved: there is more sharing of data analysis between the research groups. The 4th. National Report on Human Rights represents nearly a decade of monitoring⁴ access to human rights using standardized tools. This last report confirms a trend identified in the previous reports that despite improvements in the economy and a reduction in economic inequality, profound inequalities survive in the country in access to human rights (in its breadth), in particular in access to justice and in the continued presence of state agents as perpetrators of gross human rights violations. An analysis of the four reports will allow some progress in the identification of the role that the continued violations play for the development of a culture of respect for human rights and about the quality of democratic governance.

Progress was also made in terms of answers to the questions that guide the research program, as exemplified by two projects: a) the measurement of impunity in the case of homicide in São Paulo, revealed that the high levels of impunity are not limited to the very low clearing rates for homicide cases but worse, the few cases of homicide that are tried in court, result in such short sentences that these cannot have deterrent effect, suggesting that the state fails to demonstrate that the law can inhibit crimes against life; b) the study about the drop in homicide in the state of São Paulo, seeks to establish the real size of the drop, the pattern of reduction (whether universal across all age groups, income, gender, neighborhood profile and so forth) and the causes for the reduction, testing the hypothesis present in the literature. This project is revealing not only that the drop in homicide is not homogeneous across the cities studied, but that neighborhoods that previously were not affected by this problem begin to be affected by homicide. Homicide did not fall at the same

rate across age groups: homicide rates for adolescents, and pre-adolescents, fell much less than that of young adults and mature persons. The hypotheses tested so far indicate that, though the traditional causes attributed to homicide drop cannot be rejected, they alone cannot explain the process of homicide reduction in São Paulo.

2.1. Qualitative analysis of the research activities

A number of papers are being written as result of the exploratory analyses:

a. Obstacles to the freedom of movement

This paper analyzes the role that fear of violence and violent victimization plays in the right to freely move around the city. The paper analyzes data on fear of violence and measures adopted to reduce fear (including changes in the use of transport and avoidance of districts, and routes) from the surveys on exposure to violence. This data is complemented by data from transport surveys on Origin and Destination, and official data on homicide, robbery followed by death and drug trade, by location to examine if the territories in which this violence occurs acquire the image of “no-go” areas, for the general population, imposing a de facto obstacle to the freedom of movement.

b. Obstacles to citizenship: the right to a birth certificate

Twenty three years after the Census Bureau identified that birth certificates were not an universal document in Brazil, and 13 years after the issue of the 1st National Human Rights Program that pointed to the need for free birth registrations and of the federal law that eliminated all charges to register births and deaths in the country, as evidenced by the National Reports on Human Rights birth certificates are still not universal. Every year numerous children are born and not registered. Although the numbers vary across the country this problem exists in every state of the country resulting in lack of citizenship and lack of access to any rights and services that exist. The paper explores the relations between violence and absence of birth registration. The paper analyzes the distribution of homicide and the absence of birth certificate across the territory contrasted, against the demand for the intervention of legal services from local Centers for Citizenship and Integration (CICs) to determine paternity and others that could explain lack of birth registration. The hypothesis that is being explored is that high rates of violence may prevent people from exercising rights such as the right to citizenship that demands a birth registration. Resistance of fathers to assume the paternity of children coupled with fear of retaliation or else may be one of the reasons mothers refrain from thus access to birth registration.

c. Fear and limitations on the right of freedom of speech, of association and of demonstration

This paper explores the hypothesis that high rates of violence limit the rights that residents in such areas have to speak out, to meet to discuss local problems, and to demonstrate as ensured by the Constitution. The paper examines the hypothesis that the higher the homicide rate in a neighborhood, the lower the perception that neighbors are willing to act in the defense of vulnerable groups, the lower is the perception that residents participate in meetings to discuss local problems, the greater the emotional detachment from the neighborhood, and the lower is the perception of social capital. The paper is based on data from official sources, on the surveys complemented by secondary data from the survey São Paulo's DNA by the newspaper Folha de S. Paulo.

d. Penal impunity and low trust in institutions

Results from the research on penal impunity indicated that there is high level of penal impunity for homicide cases in the city of São Paulo, between 1991 and 1997. The objective of this paper is to analyze in how far the trust that citizens have that law enforcement institutions and the criminal justice system will succeed in enforcing law and order, while respecting rule of law, is affected by this high level of impunity in crimes against life. The paper also examines the reverse: if impunity feeds opinions that favor the use of extra legal means such as abusive use of police force, and other illegal measures to apply punishment for crimes.

Line 1. The implementation (or lack of) of democratic rule of law: public security or insecurity?

L1. a. Violence and Frontiers

Parliamentary Inquiry Commissions Reports that covered events in the states of Rondônia and Acre were retrieved and analyzed. The 1999 Report by the Parliamentary Inquiry Commission on Drug Trafficking was analyzed, and relevant information related to the organized crime within the two States collected. A literature review on the relevant topics was carried out and this included thesis and dissertations. A paper has been written on the concept of “frontier” within the landmarks of Nation States, as well as on the concept of “margin”, raising questions about the image of the State and the limits to its performance.

Line 2. Public security, police performance and democratic political culture – the preconditions for a Human Rights Culture

L2.a. Police investigation and judicial process in São Paulo: the case of homicides

Quantitative analysis of police inquests and of court documents of the homicide cases retrieved for the sample registered in the city of São Paulo at the 3rd macro regional police area, in the period between 1991 and 1997, was finished. The analysis confirmed and refined the size of penal impunity for homicide described in previous reports. This analysis also contributes to confirm one of the hypotheses of the study: that penal impunity is a result of the performance of both law enforcement agents and the judiciary.

Research activities during 2009 concentrated in updating the literature review and studying types of association between the variables and the direction of the associations through statistical analysis. The literature review on penal impunity studies revealed three main branches of this literature: one focuses on the study of sentencing, a second one concentrates in the study of the flow of penal processes within the criminal justice system and the third on the study of the length of time that processes take to arrive at a sentence (time for justice to be applied). The review highlighted the multidimensional aspect of penal impunity a phenomena in which multiple variables contribute for this outcome: from the institutional environment, to judicial practices, the ideology of both lay and technical personnel, to managerial aspects of punishment. These variables combine in diverse arrangements and this in turn affects the probability that crimes remain in the flow of justice and arrive at a final sentence.

The statistical analysis, sought to explore the role that extra-legal variables (related to the profile of victims and perpetrators) as well as those related to the criminal justice system (police investigations and penal processes) played in the outcome of cases. Preliminary results do not confirm the trends identified in sentencing studies: as extra-legal factors appear to play a small role in the outcome of the homicide cases in the sample. Judicial variables play a discreet, but determinant role. Contrary to what is expected in the literature, selectivity plays a strong role in the judicial phase. This may be a consequence of managerial practices and to the management of punishment itself, in this case it is necessary to do a qualitative analysis of the arguments used by the different agents to justify their interventions and to identify the scenarios, contexts and main actors involved and their ideal images of the law and of law enforcement and justice.

The qualitative analysis of police and court documents and interviews with law enforcement agents and members of the criminal justice system was postponed to 2010 due

to the volume of data to be processed. Planning this analysis and preparing the data for the analysis was more time consuming than originally estimated. This material is now ready for analysis. Two reports have been revised and made available to the public in the NEV-CEPID/USP website and are being edited for publication.

L2.a.1. The time of justice: its impact in the production of penal impunity: In 2009 activities focused on (1) concluding the quantitative time span analysis of homicide cases, and (2) prepare the data for a qualitative analysis. In the quantitative analysis flow charts were prepared for each case of homicide. Such flow charts were designed according to the different phases involved in a penal process: 1- the police inquiry: from the moment the case is recorded to the moment investigations are closed; 2- the judicial phase is divided in two stages: from the indictment by the public attorney's office until the decision, by the judge to try or not the case; finally, the last phase is that from the formal accusation to the trial outcome.

The time counting reveals that: a) police inquiries resulting in archived cases, without indictment, lasted on average 775 days (or 25.8 months), and cases that progressed to formal indictment, the inquiries were concluded in 130 days (or 4,3 months) on average. Cases that were brought to trial lasted in total, between the time the crime was recorded by the police and a sentence by a jury, 1846 days (61,5 months). In this phase, the average distribution of time is very unequal: 19 months on average was the time for the criminal instruction phase (evidence production) and 32 months between the formal accusation the trial by jury, that is, a period in which only bureaucratic and administrative procedures for the trial. The findings suggest the need to explore flows within each phase, including those which refer to the bureaucratic activity of the notary's offices, in order to understand the dimensions of this inequality in the distribution of time to process and try the cases in the different phases.

It is expected that the qualitative analysis will help to explain why some cases reach this average time and why some do not. This analysis has required a review of the data processing system. This review is in course.

L2.b. Obstacles for a culture of human rights

L2.b.1. Democracy, Justice and Human Rights: Critical Theory Study Group: Two themes were studied by research group during the year during six months each. The first semester was dedicated to questions concerning the environment, democracy and human

rights, with three seminars having as invited guests Alaôr Caffé Alves (USP) and Raquel Rolnik, independent rapporteur of the United Nations for housing and professor of the School of Architecture and Urban Studies at USP. The presentations by the guests and the papers that the group researchers contributed to the seminars are to be published as a book. The second semester was dedicated to studies concerning dignified labor, democracy and human rights. The seminars had as guest lecturers: Jorge Luis Souto Maior (Labor judge and Law Professor of the Law School- USP), the historian Jorge Grespan, and Professor of Sociology at the University of Campinas (Unicamp) Ricardo Antunes. The research group has also started negotiations for a partnership for collaborative research projects between NEV and the Institute for Social Research of the University of Frankfurt. The collaborative research projects are to be developed during the next two years after a drafted agreement detailing the project is finalized and submitted for funding to the Agreement between FAPESP/DFG. The group had also presented a one-year research project to the Brazilian Ministry of Justice to evaluate proposals for new legislative instruments to ensure participative democracy but was not selected.

L2.b.2. Quasi longitudinal survey: exposure to violence and socially shared representations and attitudes to justice, rights and punishment and human rights: Part of 2009 was devoted to the correction of data banks, that included reviews of the coding of questionnaires and positioning of variables in the four data bases, since some questions and alternatives for answers changed position between data collections. New cross-tables were produced for the descriptive variables: age, education, income, race/ethnicity, and gender for each wave of the survey. New variables were used for data analysis: place of residence, level of exposure to violence, and satisfaction with police (police evaluation), victimization and support for torture and fear and support for human rights violations. In the initial steps of analysis charts and graphics were elaborated, aiming at an evaluation of patterns/tendencies of responses for each wave of data collection. This allowed us to identify other venues for analysis.

Preliminary statistical data treatment included multiple regression, factor analysis and chi-square. Data reveals that despite the drop in victimization in recent years, fear continued to grow as did the support for certain types of human rights violations, including for the violation of civil and political rights, a result that strengthens a concern for democracy. That fear of crime does not necessarily follow drop in crime rates is well established in the literature on fear. The novelty is its impact on attitudes to human rights. The different data sets suggest that fear cannot be assessed only on the basis of factual direct victimization measured in a fixed time frame: its assessment seems to demand that indirect victimization

be included, it is also necessary to include prevalence of victimization (ever in one's life). The surveys have not measured altruistic fear: fear for the safety of people who are dear to us. It is possible that this type of fear evokes much stronger emotional responses than fear for oneself.

The survey covers a large number of questions⁵. In order to reduce data volume to be able to carry out more complex data analysis it was necessary to reduce the data. This was achieved creating indicators for subsets of data that express the average response of each respondent for the subset of data. Thus it was possible to develop indicators of, for instance, "social capital", police image, use of violence, human rights, fear, police use of force, efficacy vis a vis the judiciary, sentencing and punishment, among others. An exploratory factor analysis of the 2006 survey data, indicated that of the descriptive variables, despite the relatively weak correlations, age was the variable most consistently related to effects of exposure to violence. Exposure to violence seems to produce many different effects even for people who had similar patterns of exposure to violent events, in other words different person react to the same level of violence in different ways. Our challenge is now to explain why this is so. A book is being prepared analyzing the consequences of continued exposure to violence to attitudes, norms and values about human rights, and three papers are under way: one on violent victimization and human rights, a second one on attitudes to the use of torture and a third one on police image, police use of force power delegated to the State and attitudes to human rights.

During this period data from the Latinobarometro waves for the period 1995-2008 were organized in a single data base. This data base will be used to contextualize the analysis of the survey waves providing a background against which to check in how far data collected in Sao Paulo deviate or follow trends identified for Brazil and for the other 17 Latin American countries included in the study. Latinobarometro does not allow for within country data disaggregation, still comparisons between countries and with the São Paulo data when applicable can be fruitful to refine our hypothesis, for this is an on-going survey, data is collected every year, the series covered by 2008 14 years of data collection, a long period during which countries faced many political changes, and finally the data has been collected in countries that have experienced different democratic transition processes and have adopted different policies in relation to human rights violations that occurred during the military regimes. This diversity represents a near natural experiment in terms of policies to cope with past violations by state agents. Do such differences affect people's support for

democracy, rule of law, a culture of respect for human rights? Organizing the 14 years of data sets was very time consuming due of the length of the questionnaires used, to the fact that part of the questionnaire is fixed but part varies according to salient economic and political issues at the time the data is collected.

L2.b.2.2. Analysis of everyday conflicts: A chapter is being written based on data from the survey waves on perception of social disorganization, and incivility as potential sources of conflicts contrasted with data from focus groups with residents in São Paulo on the sources of conflicts in every day life in São Paulo and insecurity. This chapter will be part of a book on urban conflicts and public insecurity in Latin America edited by Carlos Perea, in Bogotá, Colombia.

L2.b.3. The fall of homicide in the state of São Paulo: a diagnosis of the magnitude and causes: The research methodology combines qualitative and quantitative procedures. Data⁶ collected was analyzed and submitted to consistency tests, using statistics and geo-statistics techniques. This resulted in indicators and parameters for the analysis of the size and the causes for the fall of homicides in following cities in the state of São Paulo: Bauru, Campinas, Santos, Ribeirão Preto, São José do Rio Preto, São José dos Campos, Sorocaba, and thirty-three cities in the Metropolitan Region of São Paulo⁷. Data was collected on the following types of crimes: drug traffic, theft, theft of cars, homicide, manslaughter, attempted murder, murder in the first degree, robbery followed by death, armed robbery, and car robbery.

The data refers to the period between 2000 and 2008, resulting in thousands of cases in each type of crime. The cases were geo-coded according to date, time of day and type of crime. Also geocoded were the socioeconomic, demographic variables and the data with cause of death and the types of crime selected for the study. This data was integrated, to a Geographic Information System (GIS) basis, after the reviews of data quality and the consistency checks. Problems in the quality of secondary data, identified in the exploratory analyses, were reported to the data sources for correction and suggestions made to improve the quality of data collection. Preliminary analysis confirm the drop in homicide rates in the

state of São Paulo, but homicide has emerged in this period, in areas in which previously homicides were not present. Two of the hypotheses that were analyzed cannot be rejected: that which asserts that there is a correlation between the drop in homicide and improvements in public security mechanisms of management and control over the last decade by the State Secretariat of Public Security and that which claims that homicides fell due to changes in the socioeconomic and demographic profile of the population. Preliminary analyses also reveal that whereas that the success of public security policies in the area of homicide did not generalize to other types of crime such as armed robberies, thefts and drug trafficking.

Moreover the preliminary analyses show that, though homicides are related to changes in socioeconomic and demographic profile, including housing conditions, these relations differ across the city. Contrary to what is found in the literature on homicide, where explanations for the drop in homicide seem to apply to a city as a whole, it seems that the drop in homicide in cities in São Paulo cannot be ascribed to a single combination of factors, but that there seems to be various combinations of patterns specific to certain locations at a moment in time, as result it seem that explanations for the fall in homicides in São Paulo, must be sought at the micro-level.

L2.b.4. Analysis of the fall in homicide rate of youth in the city of São Paulo, 2000-2008: A bibliographical review of the national and international literature on homicide and on youth homicide in particular, was carried out in 2009, to identify new hypotheses to explain the fall in homicide. This review will guide secondary data collection and the exploratory multivariate analysis. Data were collected from the “Programa de Aprimoramento de Informações sobre Mortalidade” (Mortality Data Improvement Program) on death by homicide for the Municipality of São Paulo and the 96 administrative (census) districts for the period between 1996 to 2008. The first stage of data processing the rate of death by homicide for residents of the city and for each of the 96 districts were calculated to identify the evolution of homicide as cause of death, by age group and gender of the total population of the city and that of the districts. Next, the data for the 96 districts were grouped in the five zones that comprise the Municipality of São Paulo, and these into five areas (based on the Juvenile Vulnerability Index).

The initial analysis shows that the mortality rates caused by homicides have fallen in most of the districts, in the five grouped zones, in areas that present different Indexes for Juvenile Vulnerability, for all age groups and genders. However, the fall is more intense in the age group from 15 to 24 years old. This data was presented at the first seminar of the “National Institute of Science and Technology: Violence, Democracy and Citizen Security”

during the debate “Methodological aspects for a research net”. A paper reporting initial findings is to be submitted for publication in 2010. As this project is linked to the project “The fall of homicide in the state of São Paulo: a diagnosis of the magnitude and causes” the database will be used for further analysis.

Line 3. Monitoring Human Rights

L3.a. Humans Right: The Present

L3.a.1. The 4th National Report on Human Rights: The 4th National Human Rights Report was reviewed, missing data was collected, the report was edited and it is in final review to be sent to the printers.

L3.a.2. Thirty years of police violence: A literature review was updated on the following themes: (1) democratic transition and abusive use of force by the police; (2) police violence and public security policies in the 90’s; and (3) control of the use of force and police accountability. In order to analyze a lengthy data series as the one that covers 30 years⁸ of cases of police violence reported in the printed media, chronologies of relevant events that could, in theory affect police violence were produced. These chronologies refer to: changes in legislation, government and police based programs to reduce police use of lethal force, interventions by organized civil society (reports from human rights NGOs), turn over of political parties in power, changes in public security policies, and high media profile cases of police abusive use of force.

L3.b. Human Rights: The Past

L3.b.1. Mechanisms of extra-judicial reparation for victims of human rights violations: the Latin American experience: Having as starting point the country case studies and the literature review on the role of truth commissions in the transitions a methodology to process a comparative analysis of Truth Commissions in the three countries selected (Argentina, Chile e Peru) was defined. The methodology covers three perspectives:

1. Chronological and Historical perspective – including: (a) timeframe of the formation and functioning of the Commission; (b) time span covered by the Commission’s

- investigations; (c) national and international support, initiatives and participation.
- 2- Work dynamics and work load – including: (a) number of cases analyzed; (b) degree of freedom of access to truth; (c) number of commissioners; (d) type of mandate (broad or restrictive); (e) staff size ; (f) type of amnesty; (g) methodology used for case analysis (documents, depositions and statements from witnesses/victims, confrontation of witnesses, public hearings).
 - 3- Type of Reparation – including: (a) profile of violations (kidnappings, arbitrary imprisonment, torture, rape, war crimes, crimes against humanity, genocide); (b) restitution; (c) compensation; (d) satisfaction.

Having defined the methodology and characterized the Truth Commissions, in the three countries selected, in terms of variables identified in the chronological and historical perspective, the research is now concentrating in the second aspect: identifying the dynamics of the truth commissions, in particular to identify the methodology used to gather information to analyze each case presented to the Commission.

L3.b.2. Measuring the Effectiveness of Human Rights Campaigns in Latin America: the role of the Organization of American States Inter-American Commission on Human Rights, 1970-1985: The Inter-American Commission on Human Rights and the Organization of American States are in the final stages to define policies for public consultations to their archives.

L3.b.3. Citizen Security and Human Rights in the Americas, and Juvenile Justice in the Americas: Three reports were prepared on the following themes: citizen security, juvenile justice and corporal punishment. The research was divided in three geographic regions: the Southern Cone, Central America and the Caribbean, and North America. Questionnaires were prepared for each of the three themes and applied to key informants in each region.

Preliminary data analysis results were submitted to specialists at two meetings: one held in Washington, DC in May 2007 and the second one in Bogotá, September 2008. Regional consultations were also organized in Assunción, in November 2008, in San José, in March 2009; in Bogotá, in March 2009; in Bridgetown and St. Lucia, in May 2009 and in Washington, DC in August 2009. The first report to be finished was the Report on Corporal Punishment and Human Rights of Children and Adolescents (August 2009, 44 pages) and this is available in English and in Spanish and can be found in the following website:

was launched in São José, in Santiago do Chile, and in Buenos Aires in November 2009 and in Panama City and Rio de Janeiro in December 2009.

L3.c. Human Rights: The Future

L3.c.1.Fostering healthy early development: A pilot version of home visitation methodology was developed and manuals to train paraprofessional home visitors were prepared. A pilot of the pre-test is in course in two areas of high incidence of adolescent pregnancy: Heliópolis and Jardim Ângela involving 10 adolescents and their children. An international seminar with the international and national advisory committees was organized.

The manuals to train paraprofessional home visitors are being tested in the area of Jardim Ângela. To test the home visitation methodology negotiations with the Health Secretary of the Rio Grande do Sul State progressed and members of the home visitation team visited two potential sites in the Metropolitan Region of Porto Alegre: the city of Teutônia or the city of Esteio. In 2010 the pre-test will be applied one of these cities to test the both the home visitation and the manuals to train paraprofessional home visitors in a different setting from São Paulo.

Also in 2009, the International Committee of the Red Cross requested information about this experimental project for an eventual replication in high risk areas for violence in the city of Rio de Janeiro. After a number of contacts between representatives of International Committee of the Red Cross and members of the Health Secretariat of the City of Rio de Janeiro, and members of the Fundação Oswaldo Cruz, the oldest Public Health Research institution in Brazil, a decision was reached to implement the home visitors methodology in the following regions: Cidade de Deus; Cantagalo, Pavão and Pavãozinho; Fazendinha (Alemão Complex) and Linha do Trem (Parada de Lucas). The Guides for home visitation developed at NEV will be used as the basis for this program that in Rio and NEV will assist in the adaptations. The manuals to train paraprofessional home visitors will also be used and NEV will also assist the paraprofessional visitors' training.

As an outcome of this project, the Center was invited by the World Health Organization to participate in an international call for projects to define and to test a methodology to

measure the readiness of countries to prevent child maltreatment, funded by the Fetzer Foundation. The Center's project was selected along with four other projects (Africa do Sul, China, Malasia and Macedonia). Recently, a project from South Arabia joined this group. Expected results are six country case studies depicting the state of art of child maltreatment prevention. These studies must include a wide range of information, from human and material resources to actual prevention programs as well as the perceptions of experts about child maltreatment prevention.

This study is part of the study: "Preventing child maltreatment to enhance early child development" a joint effort of the World Health Organization, the Department of Violence Prevention of the Centers for Disease Control-CDC (in Atlanta) and UNICEF. The objective of this project is to reduce children maltreatment and consequently to avoid some of the negatives consequences that impact mental, physical and human development, and to promote stable, secure and affectionate relations between children and their parents.

L3.c.2. Evaluation of the program: Fostering healthy early development: The protocols for the quantitative and qualitative components of the evaluation were completed. The evaluation team received training to apply specific instruments to be used in the evaluation such as: 1. Home Observation for the Measurement of the Environment Inventory (HOME); 2. Questionnaire World Studies of Abuse in Family Environments–World Safe, Brazil Section B [translation and adaptation from the Parent-Child Conflict Tactics Scales (CTSPC)]; 3. Standardized Questionnaire –Multi Country Study on women health and home violence; 4. The Edinburgh Scale of post partum depression (EDPE); 5. Social Support Scale (EAS). The pre-test is scheduled to take place along with the pre-test.

Others Researches (Outside the Research Lines)

Police Civilian Oversight: preparation of the final report describing in detail the mandate, structure, organizational chart, freedom of action, independence from local the police forces and of the public security secretary, and an in-depth analysis of right and the capacity to follow-up investigations, or to inform the state attorney to do so, in cases of use of lethal force by the police forces. Fourteen Police Ombuds offices across the country, representing the total universe of police Ombuds offices at the time, were studied. As result a full report on the conditions and efficacy of the Ombuds offices, in relation to police use of lethal force, was written and guide on how to follow cases of use of lethal force – the steps to follow and on indicators of abusive use of lethal force was also prepared for the Special Secretariat for Human Rights, responsible for the dissemination both of the report and the

guide.

Community policing handbooks: the final version of the handbooks has been delivered to the Special Secretariat for Human Rights. The handbooks are to be published in partnership with SENASP (Secretaria Nacional de Segurança Pública- National Secretariat for Public Security). An electronic version has also been delivered but has not been made available for download.

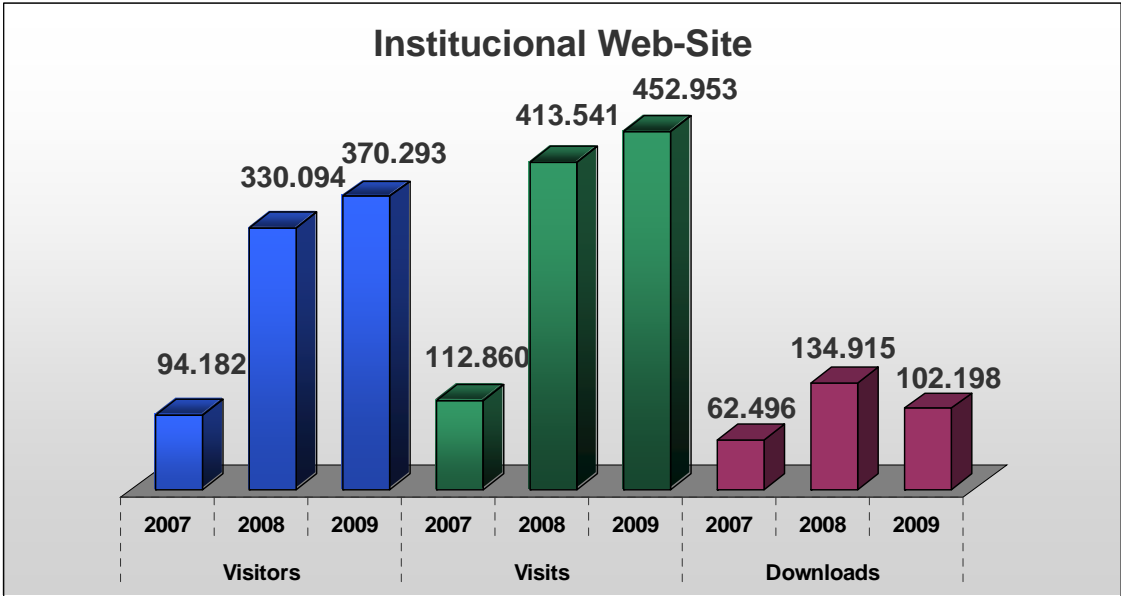
Democracy, Human Rights and Prisons Conditions in South America: This project, a partnership with the Centro de Estudios en Seguridad Ciudadana of the Universidad de Chile, and with the Centro de Estudios Legales y Sociales in Argentina, is one of the initiatives of the “Swiss Initiative for the Commemoration of the 60th Anniversary of the Universal Declaration of Human Rights – Protecting Human Dignity: an Agenda for Human Rights” sponsored by the Swiss federal government and the Académie de Droit International Humanitaire et de Droits Humaine in Geneva. The aim of the study was to describe and analyze the conditions of prisons in three Latin American countries – Brasil, Chile and Argentina – identifying the social, political and institutional aspects that allow gross human rights violations to occur in prisons. The work analyzes the current punishment policies, their main characteristics and trends, in the context of the democracies in Latin America, with emphasis on the obstacles for full implementation of the Rule of Law. Data on Argentina, Brasil and Chile are discussed with focus on penal policies and of the criminal justice system in South America. This study resulted in: a preliminary paper, an executive summary, a results summary and a final report, the latter to be launched as publication jointly with other project reports. Projeto Altus “III Semana de Visita a Delegacias de Polícia” (Project Altus “III Week of Visits to Police Stations): The Week of Visits to Police Stations is a global event organized by Altus, to: 1) evaluate the quality of the services delivered by the police departments; 2) identify police best practices; 3) strengthen the accountability by the police towards the community, and 4) promote human rights. Visitors analyze the quality of the service that the police render the public considering five parameters: 1) information to the public; 2) installations; 3) absence of prejudice-when dealing with the public; 4) transparency and accountability; 5) facilities for temporary prisoners. The project was carried out in 16 countries, including Brazil, where the following cities were visited: Rio de Janeiro, Belo Horizonte, Brasília, Recife, Porto Alegre, Fortaleza, Belém, Goiânia, São Paulo. The Center for the Study of Violence and the Sou da Paz Institute have coordinated the execution in São Paulo, where 42 police stations were visited. Further information at: www.altus.org.

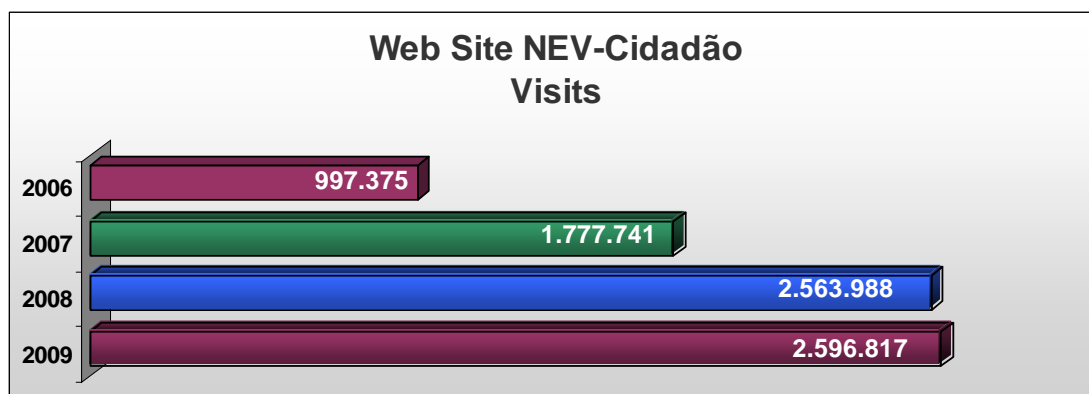

- **Youth rights' guide website:** the project is being developed and will be implemented in a school environmental in 2010.
- **Safety and Citizenship website: promoting violence prevention and transparency in the public security domain:** In 2009 the project of this site was submitted and approved for the program of the Pan American Health Organization/ Health Canada Biennial Work Plan 2008-2009, when was received financial support to the translation. In October 2009 the project also received two graduation scholarships granted by Pro-Rector of Culture and Extension. The project implementation started in November 2009.
- **Website of the National Institute of Science and Technology: Violence, Democracy and Citizen Security:** The Institutional web-site of the National Institute of Science and Technology: Violence, Democracy and Citizen Security was developed and is available for access in www.inctviolenciaedemocracia.org.br
- **Digital Human Rights Violations database:** In 2009 besides the regular maintenance of the Database, all non digitalized clippings on "Police Violence in São Paulo State", for the period between 1997 and 2008, 6.273 cases totaling 18.000 news clippings were inserted in the database. As result 60% of the cases on police violence are in digital form, including large cases which comprise the "dossiers". Cases of lynching in São Paulo State for the period between 1995 and 2008, are also in digital form. Twenty-two percent of the lynching cases are digitalized. On average 1.846 news items

are digitalized per month. The program to retrieve cases, using key-words is under test and expected to be in use by researchers in 2010.

2.3. Educational Activities in 2010

- **INCT-CNPQ Activities:** The implementation of graduate courses is being negotiated with the partner institutions. The video-conference facilities are ready for use granting access to all partners to implement joint disciplines in post graduation programs (USP, UFRGS, UFRJ, FIOCRUZ, UNB e UFC), and to share lectures, seminars, and student supervision.
- **Short Courses about human rights monitoring:** This course has been postponed due to the death of Prof. Dr. Paulo Mesquita Neto, who was coordinating the activity.
- Short term course to review the classic study “**The Authoritarian Personality**” (Adorno, T.W. & all). This course was postponed to 2010. In 2009, due to opportunity, the Democracy, Justice and Human Rights: Critical Theory Study Group had to formalize its partnership with the Violence Study Center and the Social Research Institute at the University of Frankfurt. This resulted in a project submitted to FAPESP/DFG (Brazil/Germany), to ensure financial support for exchange of scholars and the course implementation.
- **Course on Organizational Management in Public Security and Criminal Justice:** Due to a strike at the University between May and July 2009 negotiations between the University of São Paulo and the Secretariat for Higher Learning to implement the State of São Paulo Virtual University- UNIVESP, were suspended. It is expected that this project will be re-starting in 2010.

3. MAJOR OBSTACLES/ SCIENTIFIC CHALLENGES

The research program in course at NEV-CEPID combines multiple sources of data: from archival data, to official sources of secondary data, to data provided by NGO's, primary data collected from official documents, through surveys, through interviews, focus groups, case studies and through participant observations. We thus combine qualitative and quantitative sources. A sizable effort is made to collect primary data to compensate for gaps in the provision of official figures to measure phenomena: there is little reliable information for most of the subjects in our research program: on human rights access and violations, on the performance of the criminal justice system and for violent crime. Collecting data from multiple sources is a strategy to overcome the deficiencies of sources but this comes at a cost, this leads to another challenge: to integrate all the data sets in order to test hypotheses. As result not only does the research team spend much time identifying sources, retrieving data but also building data bases that must have consistency to usable and useful. Furthermore the different data sets must be compatible to be used in statistical analyses and this demands more time and effort. It also demands a special profile of research assistants: they must be resourceful, creative and capable of concentrating their attention to find problems in the data. They must also be capable to handle frustration well for tidying the data bases can demand much effort and the rewards to be gathered much later on.

Until recently the data collected focused on the state of São Paulo, with greater detail and volume of information for the Metropolitan Region of São Paulo. The four National Reports on Human Rights as well as the Data Base on Human Rights Violations were the only instances where the approach became national. With the **National Institute of Science and Technology: Violence, Democracy and Citizen Security** the limitation imposed by the access to data from the state of São Paulo only is being overcome. This is needed in order to identify what role each sphere of government plays in the persistence of human rights violations, in fostering obstacles for democratic consolidation and for a culture of respect for human rights. Overcoming the technical difficulties of integrating different types of data from various sources, it is expected that a national perspective will allow us to explore, with greater precision, our hypotheses and that this in turn, will lead to greater depth in the theoretical debate about the quality of democracy in Brazil.

As we confront these challenges new ones emerge as the complexity of the projects grow due to the nature of the themes involved. For instance, the project that seeks to explore the relations between the political sphere and organized crime in the frontiers, or the one

that refers to the right to truth about what happened during the military regime, or else the project to foster healthy early development. They have in common the fact that they break new ground, there are not many such projects around that we can rely on established models to adapt, even in the case of home visitation there is a great challenge as few programs in the literature have focused on adolescents and fewer still use paraprofessionals. As such they demand that the research team be prepared to deal with unexpected threats and opportunities: a good example on the positive side is that of the project on the right to truth: by chance the 3rd National Program on Human Rights proposed that a Truth Commission be formed to investigate what happened to the persons who went missing or were killed during the military regime due to their political or terrorist activities. This proposal provoked a major reaction not only from the military, but also from members of the high echelon of the present administration and from some groups in society. This public debate is enlightening not only about the resistance the groups have about the past but also about the resistance to the universal access to rights. The project on the promotion of healthy early development through the close contact with daily lives of adolescent girls, their babies and their families is revealing the loopholes in social policies that seek to attend the groups most at risk and fail. It is also providing a terrible close up of what overlapping deprivations effectively means, and how this, de facto, translates in overwhelming obstacles for the children Born under such circumstances, in families that present no resilience for them.

Historically lack of universal presence of the state over the territory, in particular in urban areas, has provided organized crime with multiple opportunities to control parts of urban areas, de facto preventing the presence of the state in such areas after crime takes control. This enfeebles the state capacity to enforce the law and thus control crime and violence. The three on-going projects at the NEV focus on organized crime and they all present challenges to a varying degree. The project on Violence and Frontiers is perhaps the most complex as it involves: a) relations that are difficult to bring to light and b) involve new themes-that of the relations between frontier territory and violence and crime. The frailty of local institutions, the permanence of traditional forms of exercise of power (by force rather than by popular representation), the collusions that institutions tend to establish, the lack of independence by local media, represent major difficulties to have access to data.

A second project on organized crime analyzes the social networks present in a major report on Drug trafficking in Brazil by a Parliamentary Commission of Inquiry by the Brazilian Congress. Through the use of a methodology of social networks, it is possible to establish how criminal careers develop involving actors from all sectors of society.

With the support of CNPq, an analysis of events that took place between May and September 2006, in the state of São Paulo, when groups identified as belonging to an organized crime faction the PCC (First Command of the Capital) are being re-constructed, with the help of reports by the media. The attacks took the form of a number different of events, with different targets concentrated in a short time span (waves) affecting the Metropolitan Region of São Paulo as well as major cities in the interior. The project identified chronological relations between prison riots since the 1980's, changes in public security policies, changes in prison management and political changes. Following The chronology of events and that of political changes seem to be related.

Another project that focuses on organized crime is that about the illegal markets in Rio de Janeiro in the INCT-CNPq. It is expected that this project will provide a large contribution to the analytical framework on the impact that organized crime brings to the studies on the quality of democracy.

4. POTENTIAL PROBLEMS/BOTTLENECKS

The research program presents numerous theoretical and methodological challenges. One example is the case of studies that involve organized crime. From the theoretical perspective, there is no consensus about the concept of “organized crime”. Many scholars question the validity and the applicability, of the concept since there is no agreement as to which operations and strategies for action constitute “organized crime”. Is it legitimate to apply models used to study máfias to a context of organized crime such as Brazil? There is much debate on this issue and Brazilian researchers are working in the clarification of the concept.

From the methodological perspective the challenge is to research themes considered to be “dangerous”, that is, with low visibility, low public access and bringing risks to researchers. At present most of the studies in course use open archival data, analyzing the quality of the data, and the sources. Sometime in the future it will be necessary to do some field work and this will entail other risks.

A recurrent problem is that of the demand for knowledge transfer, in particular through the media whose demand varies as consequence of events in society at large. This past year we adopted two measures: to broaden the participation of junior researchers in knowledge transfer with more presence to respond to media demands and up date and expand our referral list so that we can refer editors, journalists and producers to other sources in academia.

Negotiations to institutionalize the Center, continue though at a slower pace due changes in the Administration of the University, with the election of a new Rector at the end of 2009. Progress was made though in terms of space as two new rooms have been allocated to NEV: an amphitheater and a new library room and this should reduce the crowding in present facilities.

5. OBJECTIVES TO BE ACHIEVED IN 2010

5.1. Research

Line 1. The implementation (or lack) of the Rule of Law: public security or insecurity?

Violence and Frontiers: The following activities are scheduled for 2010: a) –continued literature review and analysis of the literature collected in 2009; b) – cross-referencing information collected in the different documents (depositions, statements and formal questionings) and reports of the Parliamentary Inquiry Commissions, as well as the legislation and official documentation collected in 2009; c) – collection of information from the system of criminal justice in the States of Acre and Rondônia on the white collar crime, corruption and on the profile of criminal violence; d) – literature review and analysis of violence and frontiers in the relevant international literature; e) – organization of two research workshops at NEV; f)- organization of two research workshops in Rondonia and in Acre with local partners; g) – participation in the INCT Workshop e h) – production of two papers.

Line 2. Public security, police performance and democratic political culture – the preconditions for a Human Rights Culture

L2.a. Police investigation and judicial process in São Paulo: the case of homicides

The qualitative analysis of the archival documentation on police inquiries and the judicial processes is to be finished in 2010. Complementary data is to be collected through interviews with police officers and agents of the criminal justice system working specialized in homicide. An analysis of the Penal Code and relevant legislation that regulates the performance of the system will also be carried out.

We expect to publish three papers based on research results: 1 - one on justice flow in the case of homicide that occurred during the 1990's in the city of São Paulo; 2 – and one about the time of Justice: its impact on producing penal impunity, as well as a paper with the results from the qualitative analysis.

L2.b. Obstacles for a culture of human rights

L2.b.1. Democracy, Justice and Human Rights: Critical Theory Study Group:

During the first semester of 2010, the group will concentrate on the study of the theme “theory and practice of the radicalization of democracy”. Lecturers will be invited to present seminars to the group on this subject. In the second semester the group will focus on democracy, human rights and education. Negotiations to strengthen the partnership between NEV and The Institute for Social Research of the University of Frankfurt will continue. Funding for joint seminars, exchange of scholars and internships was requested. Preliminary internships have taken place through a post-doctoral period at the University of Frankfurt and at The Institute for Social Research and more are expected to follow.

L2.b.2. Quasi longitudinal survey: exposure to violence and socially shared representations and attitudes to justice, rights and punishment and human rights:

Statistical treatment of the data is to be continued and the following analyses are scheduled: a) patterns of victimization and re-victimization – who is most at risk and why? What changes over time in such patterns? Here descriptive variables will be expanded to include religion and place of residence, and b) the impact that victimization and in particular multiple victimization have on attitudes, norms and values (in relation to the causes of violence and on the use violence), trust in institutions (police, judiciary, delegation of power), human rights (beliefs about torture, the protection of civil and political rights) and rule of law (respecting the law versus accepting informal forms of punishment) and social capital. Is there an impact of violent victimization on people’s values and beliefs? If so, what is more likely to be affected? Does this impact (if present) change over time? These results are to be used in the book on violence and human rights in preparation.

By request of the Special Secretariat for Human Rights the questionnaire use din the regular survey in São Paulo is to be applied to 11 state capital and the results compared to those from 1999. This will result in a book, published by the Special Secretariat. Data from the survey was also used for the introduction for the book that presents the papers from the International Seminar on Torture. Edição do livro sobre a violência e os direitos humanos.

L2.b.3. The fall of homicide in the state of São Paulo: a diagnosis of the magnitude and causes:

Qualitative and quantitative analyses will be carried out: statistical and spatial analysis techniques will be used to test the evolution of intentional homicide in the period from 1996 to 2008, in the six cities selected for the study as well as the Metropolitan Region of São Paulo. Data on crime and on the socioeconomic and demographic profile of residents will be used explore space-time patterns for murder in the

first degree and its causes and to identify the key variables for the fall of this type of crime.

L2.b.4. Analysis of the fall in homicide rate of youth in the city of São Paulo, 2000-2008: Secondary data collection will continue. The statistical analyses will start with: 1- an exploratory analysis to evaluate the distribution and frequency of youth homicide; 2) bi-variate analyses; 3) multivariate analyses to test specific hypotheses for the fall in youth homicide as compared to that for the total population in the city of São Paulo. A paper shall be submitted for publication based on the descriptive analysis of data and another one based on the multivariate analysis.

Line 3. Monitoring Human Rights

L3.a. Human Rights: The Present

L3.a.1. 5^o National Human Rights Report: The 5^o National Human Rights Report is will start with two main objectives: a) to continue the data collection on human rights violations, as done in previous Reports data collected for the 5th Report, will refer to the years 2007-2009; and b) the Report will present a “balance of the decade” (1999-2009). This will include: a) an analysis of the data, for the decade, in terms of its temporal evolution; b) an evaluation of the quality of the available sources; c) an assessment of the degree of public access to the data; d) an analysis of the advances and regressions in terms of public policies regarding mechanisms to protect human rights. During 2010, research assistants will actively participate in this Report and training will take place early in the year also new sources of data will be identified. The first draft of the Report should be ready by the end of the year. “Special rapporteurs”, meaning experts in the different areas covered will be identified and invited to collaborate analyzing specific themes for the “balance of the decade” section of the Report.

L3.a.2. Thirty years of police violence: The chronology represents the background for the analyses. The literature review is also guiding the analyses identifying new indicators of police abusive use of lethal force. The analyses will use data collected in other on-going research projects at the Center besides the Data base on gross human rights violations, such as the survey, regularly published data provided by the Secretariat of Public Security on police use of force, theses, dissertations and papers on the subject. This analysis will include newspapers chronicles (signed pieces written by journalists or columnists, editorials, opinions, letters from readers and so forth) published in the period 1980-2009, that comprise

the data base on police use of force.

L3.b. Human Rights: The Past

L3.b.1. Extra-judicial mechanisms of reparations for victims of Human Rights Violations: the Latin-American experience: the research will focus on the comparative analyses, as defined in 2009, of the Truth Commissions in the three countries Argentina, Chile and Peru. This will be followed a by the analyses of the extra-judicial reparations to victims of gross violations of Human Rights. This will result in papers for publication.

L3.b.2. Measuring the Effectiveness of Human Rights Campaigns in Latin America: the role of the Organization of American States Inter-American Commission on Human Rights, 1970-1985: We are still waiting for the authorization to have access to the documents. Once the authorization is obtained, the data collection will be started.

In 2010 two reports will be finished and published – **Citizen Security and Human Rights in the Americas**, and on **Juvenile Justice in the Americas**, both under the coordination of Professor Paulo Sérgio Pinheiro.

L3.c. Human Rights: The Future

Fostering healthy early development: The activities scheduled for 2010:

- to review the pilot manuals to train paraprofessional home visitors, maintain the website “healthy childhood” and to update the home visitation guide;
- to pilot the pre-test home visitation program in São Paulo and in Rio Grande do Sul;
- to organize a seminar with members of the National and International Advisory Committee;
- to train the First Childhood Program (PIM) team (a program from the State Secretariat of Health of Rio Grande do Sul) to implement the Visitation Program in one city of the Rio Grande do Sul State (probably the cities of Teotônia or Esteio);
- to follow 15 pregnant adolescents or adolescents who recently gave birth during a full year (2010), in the city of São Paulo;
- to continue to advise the International Committee of the Red Cross to implement, in partnership with the Secretary of Health of the city of Rio de Janeiro, a home visitation program to promote a healthy development of children;
- to share the information and the techniques of early development stimulation, which are

being used by the paraprofessionals to health agents from the Casa do Adolescente (Teenage Center) in Heliópolis, São Paulo to sensitize and inform pregnant adolescents and adolescent mothers on how to promote a healthy development of their children;

- to test the tools to evaluate the program Fostering healthy early development: pre-testing the quantitative and qualitative instruments from the evaluation protocol.

New themes are being introduced such as public transport. Evaluate user's satisfaction. Social media campaigns (Twitter).

- **Safety and Citizenship website: promoting violence prevention and transparency in the public security domain:** Management and implementation of the website content; translation and adaptation of the international reference material; developing introductory basic material on relevant subjects.

- **International Conference about the Right to Truth:** Maintaining the site up to date with the material from the study group on the Truth Commissions and the on-going debate on the recently established Brazilian Truth Commission.
- **Digital Human Rights Violations database:** Finalize the digitalization of remaining cases of Police Violence in São Paulo and Rio de Janeiro from the 1980's, and other

states in Brazil from 1980's, 1990's and 2000's. Cases of Lynching for the decade of 1980's will also be digitalized (São Paulo 1980's, Rio de Janeiro and Brazil from 1980's, 1990's and 2000's). The digital processing of cases of Extrajudicial Executions, for all locations and decades will also be finished. A review is being made as cases are digitalized. In the first half of 2010 it will be possible to consult the cases in a text format and no longer as images.

5.2.3. Others

NEV-Unesco Chair on Human Rights Education: Maintenance of collaboration with the UNESCO Chair on Human Rights Education in order to optimize efforts by both institutions.

5.3. Educational Activities in 2010

Course of Organizational Management in Public Security and Criminal Justice. This course will be offered by UNIVESP – Virtual University of the State of São Paulo, the result of the cooperation between the Secretariat for Higher Education of the State of São Paulo, the Paula Souza Center and the three state universities of the state of São Paulo, with the support of Fundação de Amparo à Pesquisa no Estado de São Paulo (FAPESP), of The São Paulo Foundation for Management Development (FUNDAP), the Padre Anchieta Foundation (FPA) and The Imprensa Oficial Printing House. This course consists of 18 lectures taught by professors from different schools in the University of São Paulo: the School of Philosophy, Languages and Human Sciences, the Law School, the School of Economy and Management and the Engineering School- Escola Politécnica), the Getulio Vargas Foundation, the School of Prosecutors of São Paulo, University Candido Mendes, State University of Rio de Janeiro, Pontifitian Catholic University of Rio Grande do Sul, a specialist in reform of the judiciary from the World Bank, a member of the Portuguese Police and a researcher from the Centre National de la Recherche Scientifique (France).

APPENDIX 2 – KNOWLEDGE TRANSFER ACTIVITIES

2.1. Seminars organized by NEV

2.1.1. Seminars open to the general public

International Conference on the Right to Truth on 19-20 October 2009: The objective of this Conference was to promote a debate on the Brazilian Amnesty Law (Lei nº 6.683/79) and its effects over the last three decades, focusing on the right to truth. After 45 years of the coup d'état that instituted the military regime in the country, families of insurgents who died or went missing for political reasons, still do not know what happened to their relatives. Victims of crimes committed by State agents, such as illegal prisons, kidnappings and torture, still seek justice and reparation. In this context, society mobilizes to demand the right to truth, with access to the archives from the dictatorship and the disclosure of the facts that took place at that period of our History. After all, it is both the duty and the responsibility of the State to reveal the truth to its citizens, ensuring the non-repetition of the violations of rights institutionalized during the authoritarian government. Democracy and the rule of law can only be achieved after the State deals with its past. Knowledge of the facts can promote true reconciliation. Reparation for victims, with the restoration of their moral dignity, and the construction of the collective memory, only can derive from knowledge about the truth. All the presentations were broadcasted through IPTV and may be watched on the Internet in the following site: www.nevusp.org/direitoaverdade.

Results achieved: The Seminar was attended by 132 persons at the auditorium Professor Francisco Romeu Landi, at USP, nevertheless such number may be slightly higher, since not all the persons present formally registered and there was IPTV broadcasting for the Department of Sociology of the Universidade de Brasília, and for the Laboratory for Studies of Violence of the Universidade Federal do Ceará (Professor César Barreira). There was no record keeping of this audience transmissions.

Media impact: repercussion in the following vehicles: “Folha de S. Paulo” and “O Estado de S. Paulo”; the news website “BBC News” (International) and “Terra” and “Rádio CBN” and “Correio do Povo” (RS) besides in “Jornal da USP”. A book is being prepared for

broad national and international academic diffusion. The website of the International Conference on the Right to Truth, developed for the diffusion of the conference, was reformulated in order to host the videos of the presentations and the debates, historical documents and informations on the subject theme. It shall be maintained by NEV for the next 12 months in the website for open research of any audience.

International Conference on Human Rights – Protecting Dignity / Date: 21st of December 2009 / Place: MuBe – Museu Brasileiro de Escultura, São Paulo – SP

Organization: Government of the State of São Paulo with the Secretariat for Institutional Relations Secretary of the State of São Paulo, in cooperation with the Federal Department of International Affairs of Switzerland in collaboration with the Geneva Academy of International Humanitarian Law and Human Rights and the Center for the Study of Violence, NEV/USP and the support of the Secretariat of Justice and the Defense of Citizenship.

To celebrate the 60^o birthday of the Universal Declaration of Human Rights, the Swiss government launched in December 2008 the project: Protecting Dignity: an agenda for Human Rights. The reason for this being that though countries endorsed the Universal Declaration this endorsement has not been translated in effective actions and public politics to implement the principles of the Universal Declaration. This initiative by the Swiss government aims at on the one hand a balance of achievements derived from the promotion and protection of human rights up to present, and on the other to reiterate the the weight and the importance that human rights deserve in the XXI century, and to encourage the study and monitoring of rights enforcement.

In 2008, the Panel held meetings in Geneva, Oslo and Vienna, with the support of the government from Switzerland, Norway and Austria to discuss present challenges for human rights. The agenda that resulted focuses on the need to respond to the challenge of poverty, to promote access to justice and to Rule of Law, to recognize that States the shared responsibilities and to create effective mechanisms for the protection and implementation of human rights. The agenda prioritizes eight themes: human dignity, violence prevention, arrests and prisons, migrations, the right to health, climate changes and a world court for human rights violations. The agenda was formulated by a Panel formed by experts and long time activists in the field of human rights. In São Paulo members of the panel presented the agenda, as well, as preliminary results for two studies on human dignity and vulnerable groups and for the creation of an international court for human rights violations. The following members of the Panel attended the Conference in São Paulo:

- Paulo Sérgio Pinheiro (co-president of the Panel, member of the Interamerican Commission of Human Rights – Organization of American States, Washington former independent expert of the United Nations Secretary General on violence against children, former State Secretary of Human Rights of the Federal Government in Brazil);

- Vitit Muntarbhorn (Special Rapporteur of the UN for the North Korea and former Special Rapporteur for the pornography and sale of children);

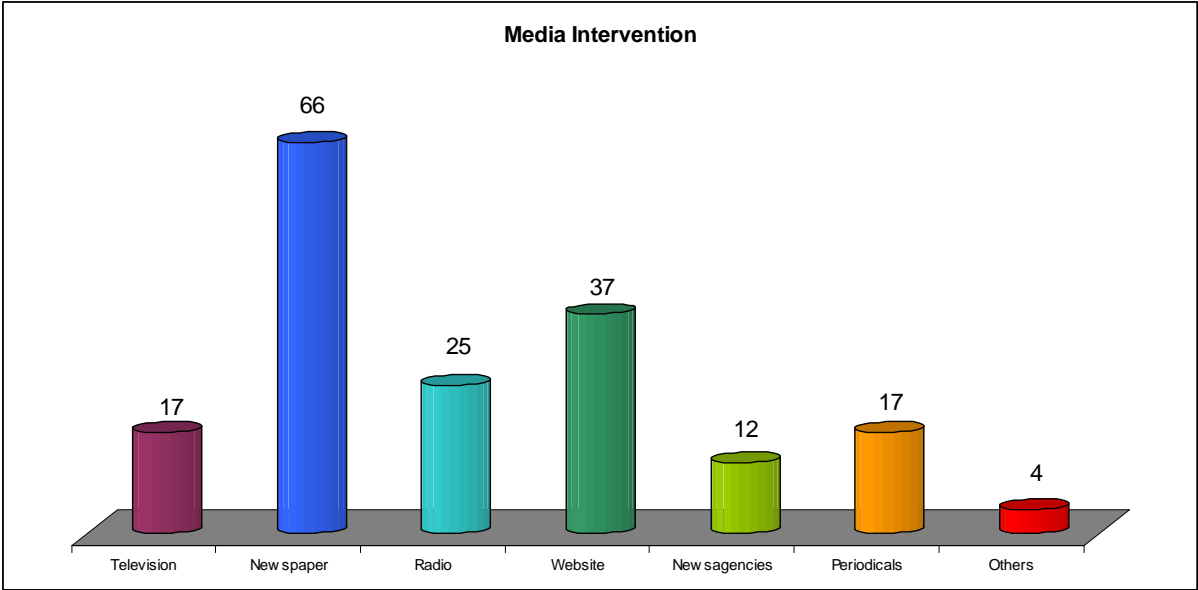
